OO3 CHAIR BUNN: Calls the meeting to order at 10:05 A.M.

I would like to recommend to the committee the following action, and open it up for discussion: I'd like to recommend that the committee adopt the SB

152-B35 amendment, which would have the effect of removing the issue of the

employer mandate from SB 152. The employer mandate issue is dealt with in an identical manner in SB 1155, which passed the Senate last night and is on its way to the House. By dealing with the employer mandate in a separate

bill, it allows us the opportunity to deal with the health care reforms in SB 152 in a way that does not endanger the passage of those reforms. It would be my hope that the committee could adopt those changes and limit the

changes to those that I've outlines.

016 $\,$ SEN. LEONARD: Asks for clarification of the -B35 amendment. (Rep. Brown and Chair Bunn $\,$ clarify.)

019 CHAIR BUNN: It is my intent as Chair of this committee to work in such a

way that the issue of employer mandate repeal would move through the legislative process first, so that in terms of those two bills, the employer mandate issue would get to the Governor's desk first, and SB 152 to the Governor's desk second.

024 REP. LUNDQUIST: I'm in agreement with that, but I understand there's word that the Senate may walk out of here at any time; I want to be assured

that the employer mandate isn't going to get sidetracked. How long does the

House have to meet before we can take action on it?

O29 CHAIR BUNN: I would suggest two things: First of all, that while we agree in Conference Committee, that we all hold off on signing this Committee Report until I can report to all of the conferees on the status of those things. It is my recommendation that the employer mandate bill, SB

1155, go to the Rules Committee. I have been working to try to assure that there would be no Minority Reports. The Democratic Caucus in the Senate cooperated with no Minority Reports. If we can get that in the House, it should move through successfully, but by holding off on signing this Conference Committee Report, it gives an opportunity for me to report to you on that issue.
