- 175 REP. MANNIX: I got my amendments at 2:30 also. I would like to see that we get a printed bill.

- 180 SEN. LEONARD Would like to give the Governor 2 days to review amendments.
- 190 REP. WATT: Agrees with his Rep. Mannix.
- MOTION: REP. MANNIX: Moves to ADOPT SB 369B-32 amendments dated 05/26/95 and that the bill be further amended on page 123, line 15-24, by deleting the bolded language should be deleted and restore the old language. On line 27-28, "or aggravation" should be bracketed and italicized.

VOTE: Hearing no objection the motion CARRIES.

MOTION: REP. MANNIX: Moves SB 369B be sent to the floor with a DO PASS AS AMENDED recommendation.
