CHAIRMAN MEEK: Opens the Public Hearing on HB 2145.

009 KAREN MOFFAT, Manager, Child Day Care Unit, CSD: Presents testimony in support of HB 2145 (EXHIBIT A).

030 REP. MILNE: What are the fees used for?

MOFFAT: Explains.

REP. MILNE: They aren't dedicated?

MOFFAT: No.

070 JUDITH D. CRADDOCK, Abuse Victim and Foster Child Advocate: Presents

testimony in support of HB 2559 (EXHIBIT B).

150 VENA WRIGHT, Parent Consultant, Lane County Child Care Resource and Referral Program, Lane County Community College: Presents testimony in support of HB 2559 (EXHIBIT C).

290 REP. NAITO: We appreciate your comments.

REP. HOSTICKA: Would be more than happy to work with the commitee if there are technical problems with the measure.

303 CRADDOCK: Makes closing comments.

313 ANN NIEDEREHE, CSD: presents testimony in opposition to HB 2559 (EXHIBIT D).

397 REP. SHIBLEY: Understands the State Archivist looks at five considerations in determining retention schedules. -Are you open to discussion of a sixth consideration or waiving the considerations or both?

NIEDEREHE: Part of our concern has always been the client's potential

future interest, but there are other considerations as well.

REP. SHIBLEY: Could some of the fiscal impact be mitigated through some sort of fee? You could charge so much per page or file.

NIEDEREHE: That's a possibility.

435 REP. SHIBLEY: If there was an unfounded alligation of abuse or neglect and that individual reached the age of majority, should that individual be able to get those records until they reach the age of 25?

NIEDEREHE: Does not have the answer. -We currently keep unfounded cases for three years. -The schedule we have on the unfounded case is in response to the issue that that state should not keep those records any longer than is warranted.

027 REP. SHIBLEY: Sometime within those three years, a parent of that minor child would have access to those records?

NIEDEREHE: The parents or legal representative of the child would have access.

034 REP. ADAMS: How many clients might there be in a given year?

NIEDEREHE: There are approximately 15,000 families.

REP. ADAMS: Using your figures, if we charge \$2 for the first biennium, and \$5 for the next biennium--why can't we do this?

048 NIEDEREHE: Responds.

056 REP. NAITO: Do unfounded cases include cases where there were never any investigations done by CSD?

NIEDEREHE: The ones kept for the three years are ones for which an assessment were done.

REP. NAITO: Over a 15 year period there could be a series of allegations.

073 NIEDEREHE: We've found if we get another referral, it usually happens within a three-year period.

REP. NAITO: If the records were destroyed how would you know?

NIEDEREHE: That's correct.

083 REP. NAITO: Have there been any discussions on post-traumatic stress

syndrome and the need to keep these records?

NIEDEREHE: There was a discussion of the impact on our records and it

was determined that we weren't required to change our record retention

schedules.

092 REP. MILNE: What could be more important in balancing than to maintain something that's so vitale to someone's life? -Is your concern about liability more important?

NIEDEREHE: The balance she referred to involves all the factors you mentioned.

108 REP. NAITO: Couldn't we move towards storing the information in the records in some cost efficient way? NIEDEREHE: There is a move of interest towards electronic storage.

123 ROY TURNBAUGH, State Archivist: Presents testimony in opposition to HB 2559 (EXHIBIT E). -He describes the current retention schedule for certain records.

157 REP. ADAMS: Do you have a copy of CSD's cost estimate?

TURNBAUGH: He does.

163 REP. ADAMS: Do you keep primarily paper records?

TURNBAUGH: Usually they come on paper or microfilm. -There is a cost associated with converting records to another medium.

REP. ADAMS: You're not currently scanning them or keeping them another way?

TURNBAUGH: No.

REP. ADAMS: Does the cost seem reasonable?

TURNBAUGH: Can not evaluate that at this time.

076 REP. NAITO: In your testimony you mentioned that you resisted pilot projects, could you elaborate?

FRANKE: Responds.

092 CATHY GARLAND, Coordinator, Marion County Children and Youth Services

Commission: Presents testimony describing the Marion County Children and Youth Services Commission (EXHIBIT I). -She describes their amendment.

215 REP. SHIBLEY: Did OCCYSC have any involvement in your five year vision and strategic plan?

GARLAND: They have provided a supporting role to our commission. She

describes OCCYSC's role.

231 REP. SHIBLEY: How does that directly relate to achieving the

benchmarks? -What process did OCCYSC go through to ensure these activities are not

just good ideas, but they are aimed at achieving specific benchmarks?

GARLAND: Describes how they use the benchmarks.

262 REP. SHIBLEY: You've discussed the importance of volunteers. Could you give us a profile of them?

GARLAND: Describes their volunteers.

281 REP. SHIBLEY: As a county office are you bound by all of the regulations affecting Marion County as an entity?

GARLAND: Describes their relationship with the county contract office. -That's an advantage of being aligned with the county.

307 REP. SHIBLEY: Is concerned that whatever we do, we keep the bureaucratic overhead to a minimum.

319 REP. ADAMS: You work up proposals to take to the county commission for funding, which suggests you are competing with other county entities for funding.

235 GARLAND: Describes their planning process for services and strategies. -We are not in competition with anyone else for funding.

356 MARILYN HERB, Director, Alternative Services, Salem-Keizer School District: Presents testimony in support of the county proposal (EXHIBIT J).

034 REP. SHIBLEY: You also talked about the importance of volunteers. -What would the bill requiring school employees to have background checks have on your volunteers?

HERB: That will have a major, but necessary impact. She explains.

HERB: Will work alone or on a team. -It's how you choose to spend your time based on the outcomes you perceive to be in the best interests of the children in the community.

REP. ADAMS: There may be ways to help you work it better.

HERB: There are interrelationships between alcohol and drugs, teen parents, youth gangs, etc. -We're finding a lot of our efforts in separate groups are coming together. -At some point we'll be able to blend some of these programs.

053 REP. ADAMS: You'd be a tremendous resource to us in trying to imagine what works at the local level.

HERB: Will be happy to participate.
