PUBLIC HEARING ON SB 798A

006 JANET McCOMB, COMMITTEE ADMINISTRATOR: Outlines the Preliminary Staff Measure Summary (EXHIBIT A) and the Fiscal/Revenue Analysis (EXHIBIT B).

025 SENATOR BOB SHOEMAKER, SENATE DISTRICT 3: Explains the history of the bill and the continuing dispute between the ophthalmologists and

optometrists. -Urges the Committee to keep the bill as written. -Does not feel legislature can judge who is eligible to administer the

drugs. -Answers questions from the members.

169 REP. MARY ALICE FORD, HOUSE DISTRICT 8: Outlines the history of SB 798 (EXHIBIT C). Amendments have been drafted to bring the bill back to its original form (SEE EXHIBIT C).

295 JOHN J. ULWELLING, EXECUTIVE DIRECTOR BOARD OF MEDICAL EXAMINERS: Submits and reviews testimony on SB 798A (EXHIBIT D). -The Board holds no position on this bill.

145 REP. WOOTEN: Do you believe optometrists have both the expertise and education to make more independent decisions?

MR. ULWELLING: Impressed with the optometrists as a profession, but do not know their expertise in the dispensing of drugs.

193 REP. GEORGE EIGHMEY, HOUSE DISTRICT 14: Gives history of the bill while in the Human Development Committee and speaks to the proposed SB 798 -A5 amendments (SEE EXHIBIT C).

270 CHARLES D. RADEBAUGH, O.D., REPRESENTING THE OREGON OPTOMETRIC ASSOCIATION: Submits and reviews testimony in favor of SB 798 (EXHIBIT

E).

150 JOHN POWELL, CENTRAL LINCOLN UTILITIES DISTRICT: Speaks to the proposed HB 3047-4 amendments. -Sections 2(a) and 2(b) are necessary.
