011 GARY WEEKS, DIRECTOR, DEPARTMENT OF INSURANCE AND FINANCE:
Outlines the history of hearings on HB 2113. -Proposed amendments would
expand the current statutes. -Discourages proposed amendments. -Issues
are: Choice on the part of the consumer; access to DRP programs on the
part of the repair facility; and quality of service. -Recommends moving
ahead on the administrative rule to clarify the

choice. -Department will take the lead during the interim bringing
together all of the parties to examine the issues of choice, access and
quality. -Answers questions from the members.
