PUBLIC HEARING ON HB 2112 069 JANET McCOMB, COMMITTEE ADMINISTRATOR: Outlines the Preliminary Staff Measure Summary (EXHIBIT B). 082 GEOFF GUILFOY, DEPARTMENT OF INSURANCE & FINANCE: Outlines the purpose of HB 2112. 128 MARY ALICE BJORK, ADMINISTRATOR, INSURANCE DIVISION, DEPARTMENT OF INSURANCE & FINANCE: Submits and reviews testimony on HB 2112 (EXHIBIT C). REP. JOHNSON: Why do premium finance companies exist? 240 BJORK: Originated for the large premiums in commercial insurance. 261 REP. JOHNSON: Is the interest regulated? BJORK: Regulation is explicit in what can be charged. 298 REP. WOOTEN: Is there an advantage to deregulation creating an imbalance and competitiveness? 312 BJORK: There are states that do not regulate premium finance companies. Competition does not increase the number of premium finance companies. 420 REP. NAITO: Will there be any regulation over the premium finance companies? 424 GUILFOY: Possibly under the financial institution regulation. TAPE 33, SIDE A 014 REP. NAITO: Questions door to door sales for premium finance companies? 019 BJORK: They would need a connection with the person they are calling on, an insurance agent or insurance company. 029 REP. WOOTEN: Questions motorist service clubs. 045 BJORK: The only thing that can be regulated, or is of concern, is the insurance product sold by clubs. 117 DELL ISHAM, AAA OF OREGON: Neutral on the bill. AAA represents 24% of the motorists in Oregon. 190 MARVIN FJORDBECK, REPRESENTING TRANSAMERICAN INSURANCE FINANCE COMPANY: Testifies in opposition to the Insurance Division deregulating. -Suggests moving the regulation now performed by the Insurance Division to the Department of Finance and Corporate Securities. -Offers proposed amendments to HB 2112, deleting the language repealing 746.405 to 746.530.

370 JACK HOLCOMB, EUGENE, OREGON: Speaks to the bill and its legislative intent (EXHIBIT D). -Shifting the burden will not save money.
