020 SEN. EUGENE TIMMS, DISTRICT 30: Outlines issues of rural health care and the history behind the bill. -Does not want to see the program end under Ballot Measure 5. -Once a hospital is closed, it will never come back to the community.

067 REP. GREG WALDEN, DISTRICT 56: Spoke to the rural health care issues. -179 of the 223 incorporated cities and towns in Oregon have less than

5,000 population. -More than half of the rural towns have no physician. -Among towns with 2,000 population, almost 3/4 have no physician. -158,000 migrant and seasonal farm workers without adequate access to

health care. -125,000 Oregonians live in 38 designated health manpower shortage

areas.

140 REP. NAITO: Would the Oregon Health Care Plan have any effect on this issue?

145 SEN. TIMMS: No.

158 REP. NAITO: Can telecommunications help?
