002 CHAIR REPINE: Calls the meeting to order at 8:37 a.m.

WORK SESSION ON HB 2034

011 JANET McCOMB, COMMITTEE ADMINISTRATOR: Outlines the bill and the proposed amendments to HB 2034 (EXHIBIT A).

023 REP. WOOTEN: Supports the bill, although concerned with the criterion standards the Department uses to judge applicants.

031 CECIL MONROE, ADMINISTRATOR, DIVISION OF FINANCE AND CORPORATE SECURITIES, DEPARTMENT OF INSURANCE AND FINANCE: Outlines the standards and criteria of bank officers vs. credit union officers.

050 REP. WOOTEN: Asks that there be written standards.

MR. MONROE: Agrees.

063 MOTION: Rep. VanLeeuwen moves HB 2034-1 to the full Commerce Committee.

VOTE: Hearing no objection, the motion carries. Rep. Naito is excused.

CHAIR REPINE will lead discussion in the full Commerce Committee.

PUBLIC HEARING ON HB 2728

077 JANET McCOMB, COMMITTEE ADMINISTRATOR: Reviews the history of HB 272 8.

091 REP. VanLEEUVEN: Because the customer made an agreement with the bank, will they get further notice regarding late fees?

MS. McCOMB: No.

098 REP. WOOTEN: Is the late fee charge separated on the bank statement?

CHAIR REPINE: According to Mr. Brawner, this depends on the type of equipment the bank uses to do their statements.

107 MOTION: REP. RIJKEN moves HB 2728 to the full Commerce Committee with a do pass recommendation.

PUBLIC HEARING ON HB 2537

172 JANET McCOMB, COMMITTEE ADMINISTRATOR: Reviews the history of the bill and proposed amendments to HB 2537 (EXHIBIT B).

190 WEBB TERWILLIGER, DEPUTY DIRECTOR, STATE MARINE BOARD: Supports HB 2537 and speaks to the proposed amendments, offering their support. -Supports the retention of both Idaho and Washington as a matter of good public policy.

212 LARRY HILL, GUIDES AND PACKERS OF OREGON: Supports the HB 2537-1 and HB 2537-2 amendments. -Suggests deleting reference to the Snake River and Idaho.

258 MR. TERWILLIGER: Agrees. This is good public policy if entering reciprocity on the boarder waters.

340 MS. McCOMB: Outlines the proposed amendments (See EXHIBIT B).

TAPE 47, SIDE A

016 MOTION: REP. WOOTEN moves the HB 2537-1 and HB 2537-2 amendments.

VOTE: Hearing no objection the motion carries. Rep. Naito is excused.

027 MOTION: REP. VanLEEuwEN moves to conceptually amend Sections 3 and 4 of HB 2537-2 removing references to Idaho and the Snake River.

VOTE: Hearing no objection the motion carries. Rep. Naito is excused.

053 MOTION: REP. VanLEEuwEN moves the HB 2537, as amended, to the full Commerce Committee with a do pass recommendation.

VOTE: Hearing no objection the motion carries. Rep. Naito is excused.

REP. WOOTEN will lead discussion in the full Commerce Committee.

PUBLIC HEARING ON HB 2821

076 JANET McCOMB, COMMITTEE ADMINISTRATOR: Outlines Preliminary Staff Measure Summary (EXHIBIT C) and proposed amendments to the bill (EXHIBIT D).

107 WEBB TERWILLIGER, STATE MARINE BOARD: Submits and reviews testimony in favor of HB 2821 and speaks to the proposed amendments (EXHIBIT E).

125 CHAIR REPINE: Would a rubber raft with a motor fall under these guidelines?

MR. TERWILLIGER: Yes. This separates motor boats from the rest of the water guiding interests. -Only applies to guided activities or those carrying passengers for

hire.

157 CHAIR REPINE: Will revenues be raised to cover the costs of the decals?

MR. TERWILLIGER: We have funding available to provide this service without generating a fiscal impact.

184 GARY GILCHRIST, GILLY'S FISHING ADVENTURES: Testifies in favor of HB 2821. -Outlines his business and the various licenses.

280 TIM MARSHAL, PRESIDENT, TILLAMOOK GUIDES ASSOCIATION: Submits and reviews testimony in favor of HB 2821 (EXHIBIT F).

305 GARY KRUM, PRESIDENT, OREGON FISHING ADVENTURES: Testifies in favor of HB 2821. -Hopes the bill will set apart those who are taking advantage by not

being properly licensed. -Explains the different colored stickers (SEE EXHIBIT F).

358 CHAIR REPINE: Is it the intention of the Marine Board to have a license denoting different classes or criteria of operation?

MR. TERWILLIGER: Yes. We have been working with the Tillamook Guides Association for more than two years.

TAPE 46, SIDE B

001 JOE ROHLEDER, OREGON GUIDES AND PACKERS: Testifies in favor of HB 282 1. -Bill is about professionalism, covering the existing guides.

023 LARRY HILL, OREGON GUIDES AND PACKERS: Testifies in favor of HB 282 1. -This as a consumer protection and safety measure, assuring coverage for any injury or damage resulting from an accident. -The boat must comply with Coast Guard regulations.

083 CHAIR REPINE: Questions the down side of the license.

104 MR. HILL: This does not raise standards for becoming a guide, it encourages people to comply with the standards.

120 MR. TERWILLIGER: Outlines the different programs and speaks of navigable waters. This does not impose new or additional requirements,

it separates the functions.
