004 CHAIR REPINE: Calls the meeting to order at 8:40 a.m.

PUBLIC HEARING ON HB 2999

010 JANET McCOMB, COMMITTEE ADMINISTRATOR: Outlines Preliminary
Staff Measure Summary (EXHIBIT A).

057 REP. LISA NAITO, HOUSE DISTRICT 15: Submits and reviews
testimony in favor of HB 2999 (EXHIBIT B).

091 JON STUBENVOLL, OREGON STATE PUBLIC INTEREST RESEARCH GROUP:
Submits and reviews testimony in favor of HB 2999 (EXHIBIT C).

145 AL THOMPSON, STANDARD INSURANCE COMPANY: States that his
company is neutral on HB 2999. -Information stating that insurance
agents share information with anyone other than MIB is incorrect. This
is privileged information.

178 CHAIR REPINE: Where does the breach take place? How do they
acquire information? MR. THOMPSON: Our company does not share this
information with anyone.

198 MR. STUBENVOLL: Once a consumer is placed on a mailing list,
it is impossible to know where the solicitation came from or how their
name

was placed on the mailing list.

276 MR. STUBENVOLL: Oregonians should be assured that their

insurance records are confidential.

290 TOM IRWIN, CONSUMER ADVOCATE, DEPARTMENT OF INSURANCE AND FINANCE: Supports the removal of the exemption.

330 CHAIR REPINE: Is there trackable evidence?

PUBLIC HEARING ON HB 2362

390 JANET McCOMB, COMMITTEE ADMINISTRATOR: Outlines the bill and the fiscal analysis (EXHIBIT D). -Speaks to the hand-engrossed HB 2362-1 (EXHIBIT E).

TAPE 61, SIDE A

022 REP. VanLEEUEWEN: Have the requirements on the "little rides" increased?

MS. McCOMB: These rides have never been licensed by the Building Codes Division.

039 GARY WICKS, BUILDING CODES AGENCY: Addresses Rep. VanLeeuwen's concerns. There is no rule at this time distinguishing between child

rides and the larger rides.

059 JIM PARK, BUILDING CODES AGENCY: A license fee is assessed to all amusement devices. This is a Department of Revenue fee only, it does

not involve inspection or other regulation.

086 MR. WICKS: Speaks to the change relative to the insurance issues.

109 CHAIR REPINE: Questions ski lifts.

MR. PARK: ORS 463.055(3) directs the agency to exempt from jurisdiction any ski lift operation regulated by the Forest Service.

139 REP. VanLEEUEWEN: Questions bungee jumping permits.

MR. WICKS: This language allows the agency, when they see an inspection report clearly indicating a problem, to refuse a permit.

176 MR. PARK: Present language deals with the threat to human life, it does not establish other standards.

343 REP. NAITO: "Kiddy rides" can be as dangerous for a child as bungee jumping is for an adult. 355 MR. WICKS: Most amusement ride operators have adequate insurance, although the cost of the insurance does vary based on the risk of the

ride.

385 MR. PARK: Pony rides and rides of this nature have not been regulated. It is difficult to make the determination of what does and does not

constitute an amusement ride.

049 MOTION: REP. NAITO moves to amend the HB 2362-1 amendments, line 3, deleting the word "or" inserting the word "and". VOTE: Hearing no objection, the motion carries. Rep. Wooten is

excused.

068 MOTION: REP. NAITO moves the HB 2362-1 amendments, as amended.

074 REP. VanLEEuwEN: States her support of this bill with the understanding that it does not include "kiddy rides" or animal operated rides in the

requirements.

VOTE: Hearing no objection, the motion carries. Rep. Wooten is excused.

082 MOTION: REP. NAITO moves HB 2362, as amended, to the full Commerce Committee with a do pass recommendation.

VOTE: Hearing no objection, the motion carries.

REP. VanLEEuwEN will lead discussion in the full Commerce Committee.
