- 011 REP. JIM WHITTY, HOUSE DISTRICT 47: Testifies in support of HB 3261 and addresses proposed amendments to the bill (EXHIBIT A).
- 023 TOM JOHNSON, HEALTH DIVISION: Clarifies amendments.

241 JANET McCOMB, COMMITTEE ADMINISTRATOR: Outlines Preliminary Staff Measure Summary (EXHIBIT B).

268 BRUCE ANDERSON, DIRECTOR, STATE BOXING/WRESTLING COMMISSION: Testifies in favor of HB 2125 and speaks to the proposed amendments HB 2125-2

(EXHIBIT C). -Bill was modeled after existing bill in Pennsylvania. -General Fund would support this type of legislation.

001 REP. NAITO: What would happen if the Commission were abolished?

MR. ANDERSON: Explains.

015 REP. VanLEEUWEN: Asked for a brief history of the Commission.

MR. ANDERSON: Outlines Commission.

O80 CHAIR REPINE: Where does most of the revenue come from?

MR. ANDERSON: Closed screen TV.

123 MR. ANDERSON: Explains that they do all of the medical examinations before the fight.

139 MIKE DEWEY, OREGON CABLE TELEVISION ASSOCIATION: Testifies in opposition to HB 2125. -Not all cable television companies provide special pay-per-view

programs. -Cable Association does not have a position on whether or not there

should be a Boxing/Wrestling Commission. -Outlines proposed amendments.

298 CHAIR REPINE: Can you analyze how much revenue is made available to cities from the 5% fee on these special events.

MR. DEWEY: Will get an estimate of the gross numbers. There will be significant fluctuations.

324 REP. WOOTEN: If the 6% fee is imposed, what would the impact be to the individual cable companies?

MR. DEWEY: Explains. -Initially pay-per-view is 3-5% of revenues.

TAPE 82, SIDE B

022 JIM EASTRIDGE, MAGOO'S TAVERN: Testifies in opposition to HB 212 5. Explains the operation of pay-per-view in his tavern. -Pays Boxing Commission \$50 for each fight and depending on the

attendance, they pay 6% of the gross receipts at the door or \$25,

whichever is greater. -Opposes any tax the Boxing Commission levies.

121 BRUCE ANDERSON, BOXING COMMISSION: Speaks to Mr. Dewey's and Mr. Eastridge's testimony. -The Commission does not promote boxing, this is a proactive commission.

177 REP. WOOTEN: What would become of the Boys Club, police boxing clubs, etc.?

MR. ANDERSON: The Boxing Commission regulates professional boxing only.

MS. CEDERLEAF: This does not mandate that the landlords rent to minors, although it states that they may.

088 PETER GRUNDFOSSEN, ASSOCIATION OF OREGON HOUSING AUTHORITIES: Testifies in support of the bill and submits an outline of his association
