submits the written testimony of Timothy Wood (EXHIBIT B) and proposed
amendments SB 444-1 (EXHIBIT C). -The Department of Justice takes no
position on the bill and recommends a referral to Ways and Means.

037 CHAIR REPINE: Is there legislation that increases the penalty?

039 MS. LEGGERT: There is a bill which gives minimum recovery of
up to \$500.

059 JOHN STUBENVOLL, OREGON STATE PUBLIC INTEREST RESEARCH GROUP:

335 GARY JOHNSON, COMMERCIAL CODES, SECRETARY OF STATE: Supports the proposed amendments HB 2022-4. -Gives history of the farm products system.

213 REP. VanLEEUEWEN: Would you object to the removal of the domestic pump language on lines 19-20, page 6 in the hand-engrossed amendments?

MR. CAPLINGER: It would be easier to keep the language. -Responds to questions regarding irrigation pumps and systems.

310 MS. SULLIVAN: Speaks to the generated revenue and what is projected. -If revolving accounts are combined, the balance of \$217,000 will go to the general fund at the end of biennium. 410 REP. WOOTEN: Concerned that the bill will be held up because of the domestic pump language.
