These amendments will be attached to a bill in another committee. -No concern with the limit of 200,000 barrels. -Explains concerns with the original bill. -Outlines proposed -2 amendments. 389 -Oregon Law.

economically feasible to send two people out on a job.

112 MR. WEIST: Emphasizes the purpose of the bill.

183 GARY WRIGHT, LOCAL 290: Addresses statements made by Mr. Egge.

223 DOUG EVERT, LOCAL 290: Testifies in opposition to HB 3005 and submits proposed amendments to the bill (EXHIBIT P). -ORS 693.010 (EXHIBIT Q) and the policy recommendation of apprenticeship (EXHIBIT R). -Letters from Oregon Building Codes regarding Plumbing Apprentices

V). -Submits a memo from Legislative Counsel regarding HB 2125 (EXHIBIT W).

116 CHAIR REPINE: Further explains the purpose of the proposed HB 212 5-3 amendments.

260 JIM EASTRIDGE, OWNER, MAGOO'S TAVERN: Testifies in opposition to HB 2125 and explains the amount of money he pays to the boxing commission. -Very little live boxing in the State of Oregon.

002 BRUCE ANDERSON, DIRECTOR, STATE BOXING COMMISSION: Closed circuit is being confused with pay-per-view. -Tax on closed circuit is not new in Oregon. -Not promoting professional boxing.

060 REP. WOOTEN: Are there other states with statutes similar to those in HB 2125?

MR. ANDERSON: HB 2125 was modeled after Pennsylvania existing law. Explains how the promoters operate. -Answers questions from the members. 124 DAVID OLSON, CITY OF PORTLAND: Testifies in opposition to the bill and explains the views of the City of Portland. -Speaks to the proposed amendments. 159 -Concern with the right-of-way compensation fee. -Fiscal impact. -Explains franchise fees. -Answers questions from the members.

TAPE 116, SIDE B

010 VAL PAULSON, LEAGUE OF OREGON CITIES: Testifies in opposition to HB 2125. -Concerned that this is a preemption of the local revenue authority.

This reduces the ability to raise local revenues. -Addresses franchise agreements. -Answers questions from the members.

077 ERIK KRAVSTEN, CITY OF INDEPENDENCE: Testifies in opposition to HB 212 5 and concurs with the previous testimony.

095 MIKE DEWEY, OREGON CABLE TELEVISION ASSOCIATION: Concerned with the bill as written. -May be difficult to collect the 6% charge per event. -Suggests the -4 amendments be modified. 175 -Language in the pay-per-view needs to be more discreet. -Answers questions from the members.

277 CHAIR REPINE: Will the FCC regulations cause lower the costs to the consumer?

MR. DEWEY: There is an estimated 10% decrease for the expanded basic

tier.
