Payne explains why he voted against this bill in the subcommittee > Rep. Beyer explains that the intent of this bill is to help all coaches not just the highly-paid head coaches > Rep. Tiernan states that the issue here is not the amount of money > Rep. Wooten states that this is not the right time to allow this bill because of how tight the state is on money 444 > Chair Johnson asks Bob Andrews whether coaches can retrieve the money placed in their accounts. Andrews states that coaches can retrieve their
