_ The (-2) amendments are very important; our consensus is that it would be almost impossible to obtain general funds and therefore we ask for the (-2) amendments to make the funding source lottery funds.

250 REP. TIERNAN: What are the programs that the bill appropriates money for?

DICK GRANT, DEPUTY DIRECTOR, AREA HEALTH EDUCATION CENTERS PROGRAM: That has been funded out of a matching program with the federal government to provide increased training for primary health care professionals by assuring that some of the training is done in rural areas.

PATTERSON: Section three would allocate dollars to provide grants for nurses providing that they practice in rural areas; there are a number of incentives for practicing in rural areas.
