Building Codes book.

224 MARILYN JOHNSTON, COMMITTEE ADMINISTRATOR: Outlines the Staff Summary and reviews the proposed amendments by section (EXHIBIT E).

380 CHAIR JOHNSON: Suggests setting the bill over and working on the proposed amendments.

005 CHAIR JOHNSON: Appoints a work group to study HB 2001. Reps. Beyer, Wooten and Starr are appointed to this work group.

WORK SESSION ON HB 2298 041 JANET McCOMB, COMMITTEE ADMINISTRATOR: Outlines the Staff Summary on HB 2298.

047 MARIE BELL, EUGENE, OREGON: Submits and reviews information on HB 229 8 (EXHIBIT F). This information is a result of several questions asked at the previous public hearing on this bill.

109 MARK HUSTON, ECONOMIC DEVELOPMENT DEPARTMENT: Answers questions from the members.

127 MIKE BULLIS, DISABILITIES COMMISSION: Answers questions from the members.

144 REP. NAITO: Offers suggestions.

MR. BULLIS: Typical calls relating to the ADA are from small businesses who are frustrated with a need to make changes that they do not feel

they can afford.

184 MS. BELL: Speaks of the vision of the employer.

193 REP. NAITO: Feels language is too broad to accomplish the goal.

224 MOTION: REP. REPINE moves to amend HB 2298 as follows: Lines 20 and 21, delete subsection 6; line 25 insert \$1 million; line 25 insert \$300,000; line 26 insert 20; line 20 insert \$750,000; and

renumber remaining sections.

264 REP. NAITO: Supports sending the bill to the Appropriations Committee. -Concern how people will apply for this program, what kind of equity is there, what will be the criteria when they apply? -Suggests this be linked with an employment situation.

293 MR. HUSTON: Concerned with the matching issue.

306 REP. BEYER: Supports the concept of this bill. -Concern with putting this program in the Economic Development

Department.

316 MS. BELL: When asking for lottery funds, it is important to stay within the context of economic development and keep it within the scope.

361 CHAIR JOHNSON: Asks for some agreement on the ceiling amount and the matching dollars.

376~ MS. BELL: Recommends a continuum and asks that grants not be ruled out.

385 CHAIR JOHNSON: Suggests proposed language be drafted into conceptual amendments.

TAPE 58, SIDE B

001 Members discuss proposed language.

037 REP. REPINE: Restates motion.

045 VOTE: In a roll call vote, the motion carries. REP. TIERNAN votes NO. Rep. Watt is excused.

050 CHAIR JOHNSON: Suggests \$10,000 as a ceiling on the amount of the loan.

062 REP. NAITO: Concern with the loose criteria. Will not support a grant of \$10,000.

074 REP. WOOTEN: Agrees with the proponent of this bill. There are circumstances where a grant may be an advisable way to proceed. -Provides the intent for rule making relative to a grant program, not to exceed \$5,000. If needed, a loan would be available for the applicant

with matching funds.

104 MR. BULLIS: This bill should focus on the need to provide the access and accommodation.

198 EMILY CEDERLEAF, MULTIFAMILY HOUSING COUNCIL: Explains concerns of placing a cap on the loan amount.

215 CHAIR JOHNSON: Restates suggested language.

MS. BELL: Willing to accept any accommodations made on this bill because the concept is important. 228 REP. BEYER: Suggests additional language. WORK SESSION ON HB 2455 275 JANET MCCOMB, COMMITTEE ADMINISTRATOR: Outlines HB 2455. -Same provisions are included in SB 81, which would be the preferred vehicle. WORK SESSION ON HB 3406 283 JANET MCCOMB, COMMITTEE ADMINISTRATOR: Outlines HB 3406. 296 MARY PEARMINE, ASSOCIATION OF OREGON COUNTIES: Outlines the bill and states that her legislative committee opposes HB 3406. -Explains concerns by section. 369 MOTION: REP. TIERNAN moves to Table HB 3406. VOTE: In a roll call vote, the motion carries. REPS. BEYER, REPINE and RIJKEN vote NO. Rep. Watt is excused. 377 CHAIR JOHNSON: Adjourns the meeting at 11:20 a.m.
