004 REP. CAROLYN OAKLEY, chair: Calls meeting to order at 1:36 p.m.

PUBLIC HEARING ON HJM1 Witnesses: Rep. Liz VanLeeuwen, District 37 Greg McMurdo, Department of Education (DOE) John Marshall, Oregon School Boards Association (OSB A)

028 REP. LIZ VanLEEUWEN: Reviews what the bill does. > This bill came out of the House Interim Government Mandates Committee and the Task Force of School Administrators.

038 GREG McMURDO, deputy superintendent, DOE: The restrictions on the use of federal funds by local education agencies is one of the irritations

apparent to the group of school administrators who met last interim. > At the same time, the Board of Education and the Superintendent of

Public Instruction were working with Senator Hatfield and others to get flexibility of certain funds. > Talks about federal legislation that has been introduced to do the

same thing as HJM1.

060 JOHN MARSHALL, OSB A: Encourages the committee to send the HJM 1 to Congress.

076 REP. JOHN SCHOON: Talks about not knowing where some funds are being spent. What keeps school districts from not using funds for what they

are earmarked?

McMURDO: Gives an example of not using funds wisely in regards to school breakfast money.

REP. SCHOON: Talks about school districts using transportation money for other things. Flexibility with funds is great as long as there is some way to know the outcome.

139 LINDA SAMPLE BROWN, Administrator: Talks about the federal companion bill introduced by Oregon Congressman Peter DeFazio.

142 REP. LARRY SOWA: Does one of the federal restrictions prevent the state from using education funds for private schools?

McMURDO: Not to my knowledge. We have state statutes that prohibit

that.

PUBLIC HEARING ON HB 2061 Witnesses: Kathleen Beaufait, Office of Legislative Council John Marshall, Oregon School Boards Association (OSB A) John Danielson, Oregon Education Association (OEA) Greg McMurdo, Department of Education (DOE)

210 KATHLEEN BEAUFAIT, Office of Legislative Council: Reviews the work that went into drafting HB 2061 which cleans up the language in the education statutes. > Notes there was no intention to change the purpose or intent of any

education statute. > Points out a minor change on p. 85 - kindergarten and prekindergarten are not considered to be grades. An amendment will be submitted to the

committee.

302 JOHN MARSHALL, OSB A: I was part of the group that worked on developing this bill. > Plans to work with Legislative Counsel to make a minor correction in

the bill.

322 JOHN DANIELSON, OEA: Talks about the group that worked on the housekeeping measure. There was no intent to change the statute. The

whole purpose was to clarify and simplify problems that have developed

over the past 25 years. It is a good bill and it should pass.

343 GREG McMURDO, DOE: Kathryn Murdock from the Department worked with the group. > Department staff has found a few simple changes but

they are not

substantive. An amendment will be prepared to address those changes.
