008 CHAIR HAYDEN: Calls meeting to order at 11:45 a.m.

WORK SESSION ON SB 61

010 JANET ADKINS, COMMITTEE ADMINISTRATOR: Reviews SB 61 and the amendments. -Discusses letters submitted to the committee after previous meeting

(EXHIBIT H).

035 MOTION: REP. BAKER: Moves to ADOPT the -3 amendments dated with the following changes: -Line 10 add "at the tribe's request" after "remove" and before "from."

057 MICHAEL MASON, ATTORNEY FOR THE CONFEDERATION OF GRAND RONDE TRIBES: Clarifies that the tribes want their burial sites to remain in tact. -Under current law, any reinterrment cost is absorbed by the developer.

070 VOTE: In a roll call vote, all members are present and vote AYE.

076 CHAIR HAYDEN: The motion CARRIES.

087 REP. ROBERTS: States that he is in disagreement with the tribes is the amendments regarding specific sites.

090 ADKINS: Reviews the -4 amendments to SB 61 and the hand-engrossed version of SB 61. -Reviews processes in bill dealing with disputes over skeletal remains

and issuing of permits.

143 MOTION: REP. PARKS: Moves to ADOPT the -4 amendments (except for Section 4, which will be discussed later) dated 6-29-93.

VOTE: CHAIR HAYDEN: Hearing no objection, the motion CARRIES.

All members are present for vote.

170 MOTION: REP. PARKS: Explains position and reason for proposed amendments. Moves to AMEND with conceptual amendments

the -4 amendments dated 6-29-93: -Discusses definition of a tool. -Page 2A of he hand-engrossed (6-30-93) bill add "that

has been exposed by the forces of nature" after the word "object" on Line 41 and restores public land.

215 MASON: Expresses concern over looters and would like to leave some of the current language in tact applying to someone who unintentionally

discovers certain artifacts. -Does not want to criminalize the occasional picking up of an arrowhead (for instance).

292 MOTION: REP. PARKS: Moves to ADOPT the boldface language of Section 4 Subsection 1 of the -4 amendments dated 6-29-93.

360 VOTE: In a roll call vote, all members present vote AYE with the exception of REP. HOSTICKA who votes NO.

364 CHAIR HAYDEN: The motion CARRIES.

365 MOTION: REP. PARKS: Moves to add language addressing Page 3 of the 6-30-93 hand-engrossed bill.

106 REP. ROBERTS: Does not necessarily want to include private land in the amendments.

112 REP. NORRIS: Expresses concern over citizens not being aware of what to do with indian objects on their own land.

the inclusion of private land with the public land

language.
