TAPE 1, SIDE A

008 CHAIR HAYDEN: Calls meeting to order. (8:40 a.m.)

\_ We will try to start our meetings roughly on time; members not present  
will be routinely excused from the full committee, however the  
Subcommittee Chairmen may have other ideas.

\_ When we meet in full committee it will be only for work sessions,  
there won't be any public testimony and the bills will move very  
quickly, so if members aren't here, even though they are excused, they  
may be missing votes and it may be more difficult to go back and vote  
again, so try to be present when the bills start coming through for  
voting.

014 CHAIR HAYDEN: Introduces the Committee Administrator, Janet  
Adkins.

JANET ADKINS, COMMITTEE ADMINISTRATOR: Shannon Gossack is our temporary  
assistant.

CHAIR HAYDEN: Asks committee members to introduce themselves and  
describe the districts they represent.

021 REP. ROBERTS: Introduces himself.

023 REP. NORRIS: Introduces himself.

029 REP. MILNE: Introduces herself.

033 REP. EDMUNSON: Introduces himself.

037 CHAIR HAYDEN: Introduces himself.

041 REP. BAKER: Introduces himself.

058 CHAIR HAYDEN: We will turn our attention to our rules; note that only technical amendments according to the rules can be made in full

committee and we won't be having public testimony, so the function of the full committee will be to accept or reject bills at a fairly quick pace.

\_ According to the rules the Chair will be an ex-officio voting member, not a member, not attending all subcommittee meetings, but will attend at the call of the Subcommittee Chair and at other times.

077 CHAIR HAYDEN: Note that public testimony will be taken only in subcommittee.

\_ If you wish to attend the other subcommittee you are welcome to sit in at any time, you won't be a voting member, but you are a welcome guest and may participate in the discussion freely.

121 CHAIR HAYDEN: The subcommittees should note that the quorum for a hearing is one member, we need five members in full committee and we

need three members of a subcommittee to vote.

\_ Minority reports do not come out of subcommittees, they come out of the full committee.

REP. ROBERTS: We won't be accepting conceptual amendments?

CHAIR HAYDEN: The rules say the full committee will only do technical amendments.

REP. ROBERTS: What if the full committee doesn't agree with the subcommittee?

CHAIR HAYDEN: It goes back to the subcommittee.

REP. HOSTICKA: Will that be automatic or by vote?

CHAIR HAYDEN: A committee can kill a bill, it doesn't have to go back; it will be either by consensus or by vote.

165 MOTION: REP. ROBERTS MOVE THAT THE COMMITTEE RULES BE ADOPTED.

169 VOTE: IN A ROLL CALL VOTE THE MOTION CARRIES UNANIMOUSLY.

CHAIR HAYDEN: The Transportation Subcommittee will consist of four members and one ex-officio member; Rep. Norris will be the Chair and he will be joined by Rep. Lonnie Roberts, Rep. Carl Hosticka and Rep. Ken Baker.

\_ The Government Subcommittee will be chaired by Rep. Del Parks and he will be joined by Rep. Jim Edmunson, Rep. Patti Milne and Rep. Sharon Wylie.

207 REP. HOSTICKA: I would like to have a running tab of the bills in committee.

\_ I saw in the bill packet today about a dozen transportation finance bills; do we expect those to come here before going to Revenue?

CHAIR HAYDEN: I notice some come here then go to Revenue; I'm not sure all minor bills will go to Revenue, some may go directly from this committee to the floor; the Speakers Office is assigning bills and I can't tell you what will be assigned directly to Revenue.

230 ADKINS: Explains bill management system.
