005 CHAIR HAYDEN: Calls meeting to order. (10:25 a.m.)

WORK SESSION ON HB 3003

015 JANET ADKINS, COMMITTEE ADMINISTRATOR: Describes HB 3003;
submits preliminary staff measure summary, (EXHIBIT A).

030 MOTION: REP. BAKER MOVES THAT HB 3003 BE SENT TO THE FLOOR
WITH A DO PASS RECOMMENDATION.

035 VOTE: IN A ROLL CALL VOTE THE MOTION CARRIES

068 JANET ADKINS, COMMITTEE ADMINISTRATOR: To bring this bill back to the subcommittee it needs a reconsideration vote as it was passed out last

week.

077 MOTION: REP. EDMUNSON AND PARKS MOVE THAT THE RULES BE SUSPENDED TO RECONSIDER THE VOTE BY WHICH HB 2509 WAS PASSED.

082 VOTE: IN A ROLL CALL VOTE THE MOTION CARRIES UNANIMOUSLY.

086 MOTION: REP. ROBERTS MOVES THAT THE COMMITTEE RECONSIDER THE VOTE BY WHICH HB 2509 PASSED.

098 ADKINS: The bill included an increase for ham radio operator plates; the chairs were concerned that this increase wasn't intended.

120 VOTE: HEARING NO OBJECTION THE MOTION CARRIES.

REP. ROBERTS: Are there amendments?

ADKINS: The bill was passed out with (-1) and (-2) amendments and the (-3) will take the ham operator plates back to the way they are now, very inexpensive.

REP. PARKS: I'm not interested in exempting the ham radio operators when we don't do that for anyone else; I'd like to work this in subcommittee.

MOTION: REP. PARKS MOVES THAT HB 2509 BE SENT BACK TO THE SUBCOMMITTEE ON TRANSPORTATION.

160 REP. NORRIS: Describes the new plates to be produced; the ham operators did get the exemption because of emergency functions.

_ There is still a bill pending, the Oregon Trail Coordinating Council has requested a special plate and we haven't completely resolved that issue.

203 JANET ADKINS, COMMITTEE ADMINISTRATOR: Describes HB 2337, submits preliminary staff measure summary, (-4) amendments and fiscal impact

statement, (EXHIBIT C).

255 REP. PARKS: I will be voting against this bill; this program isn't worth a million dollars in 1993.

REP. MILNE: Why has the driving without a license been removed?

ADKINS: The study done by DMV compared drivers that had been stickered under the program and drivers before the program started that were cited for driving without a license and didn't detect any change in driving behavior once the sticker was placed.

274 REP. MILNE: I will have a hard time supporting this also, if that amount of money isn't doing anything.

REP. NORRIS: The most frequent request we get is what will we do about those driving without insurance and that is what is behind this.

ADKINS: There is some revenue from the program, but it is costing money.
