TAPE 20, SIDE A

005 CHAIR HAYDEN: Calls meeting to order. (9:20 a.m.)

WORK SESSION ON HB 3180

005 JANET ADKINS, COMMITTEE ADMINISTRATOR: Describes HB 3180; submits preliminary staff measure summary, (EXHIBIT A).

REP. BAKER: Why is there an emergency clause; I don't view this as an

emergency situation.

CHAIR HAYDEN: Without the emergency clause it goes into effect ninety days after it is signed and that would make the summer more difficult. MOTION: REP. BAKER MOVES THAT THE EMERGENCY CLAUSE BE RESCINDED. REP. BAKER: I will withdraw my motion. MOTION: REP. NORRIS MOVES TO SUSPEND THE RULES. 042 REP. EDMUNSON: I would object; I support the emergency clause. REP. BAKER: The Attorney General, (AG), said they could do this now. REP. ROBERTS: We have to give these people flexibility; this allows the flexibility and it gives young people jobs and training. 063 VOTE: IN A ROLL CALL VOTE THE MOTION CARRIES. MEMBERS VOTING NO: ROBERTS, WYLIE, EDMUNSON.

MOTION: REP. BAKER MOVES TO STRIKE SECTION THREE OF HB 3180,

WHICH IS THE EMERGENCY CLAUSE FROM THE BILL.

REP. ROBERTS: I will vote no.

REP. WYLIE: Will there be a delay to keep kids from being hired?

086 REP. NORRIS: By including the emergency clause we will give some emphasis for this particular season.

102 VOTE: IN A ROLL CALL VOTE THE MOTION CARRIES. MEMBERS VOTING NO: EDMUNSON, NORRIS, ROBERTS, WYLIE

110 MOTION: REP. NORRIS MOVES THAT HB 3180, AS AMENDED, BE SENT TO THE FLOOR WITH A DO PASS RECOMMENDATION.

120 VOTE: IN A ROLL CALL VOTE THE MOTION CARRIES UNANIMOUSLY. CARRIER: REP. MILNE

REP. EDMUNSON: I would request that the subcommittee members bring up issues with emergency clauses in subcommittee; this bill came out of subcommittee on a unanimous vote with the emergency clause and I would hope that these matters would be dealt with in subcommittee.

WORK SESSION ON HB 2345

JANET ADKINS, COMMITTEE ADMINISTRATOR: Describes HB 2345; submits preliminary staff measure summary, (EXHIBIT B).

170 REP. NORRIS: This is my bill; I think it is only fair that we have this geographical representation.

REP. HOSTICKA: I voted no in the subcommittee; explains vote.

\_ The power planning council was constructed as a quasi-governmental organization and doing this, even though Washington has done it and it has been found legal, the possibility continues to exist that you'll

have one representative representing 20% of the population of the state and the other representing 80% of the state and I don't think that is

good government.

200 REP. ROBERTS: I think that we have a problem where people in Eastern Oregon feel a lack of representation; the population isn't there, but

the land mass is.

\_ It would be a good thing to let them know that someone that lived in the area was on the council.

REP. EDMUNSON: Has anyone from the Eastern part of the state ever been

a member?

REP. NORRIS: No, not in thirteen years.

REP. HOSTICKA: Norma Paulus was on the council and she claims roots in Eastern Oregon; the question of who is an Eastern Oregonian is a question that will have to be answered.

REP. EDMUNSON: People in Eastern Oregon feel that there are two Oregon's.

REP. MILNE: When I lived in Washington I was on the "wrong" side of the mountain, with those on the other side making all the rules; now, being on the "right" side of the mountain, I can emphasize with Eastern Oregon getting the representation that they deserve.

252 MOTION: REP. NORRIS MOVES HB 2345 TO THE FLOOR WITH A DO PASS RECOMMENDATION.

REP. HOSTICKA: I don't believe that by putting this in law we are

guaranteeing this.

REP. ROBERTS: We have people in Eastern Oregon that live there now and

they have a right to have someone on the council.

290 VOTE: IN A ROLL CALL VOTE THE MOTION CARRIES. MEMBER VOTING NO: REP. HOSTICKA CARRIER: REP. NORRIS

WORK SESSION ON HB 2633

315 JANET ADKINS, COMMITTEE ADMINISTRATOR: Describes HB 2633; submits preliminary staff measure summary, (EXHIBIT C).

348 REP. PARKS: By authorizing this we are authorizing Jackson County to compete with Klamath Falls and I think that is okay.

CHAIR HAYDEN: Is this a new departure; this will allow a private

corporation to set up trade zones?

REP. PARKS: No, the trade zone is a public facility, but within the zone most of the property is privately owned; this doesn't define who owns the property within the zone.

CHAIR HAYDEN: Who will have administrative control of the trade zone?

REP. PARKS: Ours is with the Port of Klamath Falls. REP. WYLIE: I believe the county is taking the lead role; I strongly

support this bill.

400 REP. NORRIS: This is permissively enabling, not really targeted

in one place.

ADKINS: Municipal corporation isn't defined in this statute; it may depend on if the county has a charter; Jackson County is a municipal corporation.

CHAIR HAYDEN: Are municipal corporations limited to public bodies? ADKINS: They are public bodies; if you want to make it clear that all counties could do this you might want to say that.

430 REP. ROBERTS: Why the emergency clause?

CHAIR PARKS: There is a pending application and there are time lines.

MOTION: REP. EDMUNSON MOVES THAT HB 2633 BE SENT TO THE FLOOR

WITH A DO PASS RECOMMENDATION.

435 VOTE: IN A ROLL CALL VOTE THE MOTION CARRIES UNANIMOUSLY. CARRIER: REP. WATT

445 JANET ADKINS, COMMITTEE ADMINISTRATOR: Describes HB 3067, submits preliminary staff measure summary, (EXHIBIT D).

018 REP. ROBERTS: I don't see a description on if the bottle must be corked or bagged.

BARBARA PELLETT, OREGON LIQUOR CONTROL COMMISSION, (OLCC): The original legislation said it must be sealed, so the cork or screw cap must be put back on.

050 REP. EDMUNSON: This only brings these organizations under the same law that exists for restaurants; it is conforming, rather than creating any new right.

063 MOTION: REP. PARKS MOVES HB 3067 TO THE FLOOR WITH A DO PASS RECOMMENDATION.

068 VOTE: IN A ROLL CALL VOTE THE MOTION CARRIES UNANIMOUSLY. CARRIER: REP. BAKER
