245 ADKINS: Legislature currently has control over the economic development part, but not over the prize money and the administrative expenses.

258 KATHLEEN BEAUFAIT, LEGISLATIVE COUNCIL: The provision that bans the growth of state expenditures, does not apply to the lottery expenditure either for prizes or for the administrative expense.

REP ROBERTS: This is written so loosely that they are paying out

something like 83% of the prizes, there is not that much going into

economic development.

291 REP EDMUNSON: Refers to missing page of Attorney General testimony. (pp 20)

319 BEAUFAIT: The Attorney General has relied on the phrase in the constitutional amendment that says that the monies that are deposited in this particular account are continuously appropriated for the purposes

of administration of the lottery and that lifted the control completely away from the legislature.

356 REP HOSTICKA: If this bill becomes law and the lottery wants to challenge it, is the Attorney General obligated to defend the state?

BEAUFAIT: The Attorney General would feel committed to defend the

lottery.
