280 REP. PARKS: Does not feel that this bill needs to be referred to Appropriations.

testimony, there was indication that this is going to be a future problem for people. 424 REP. NORRIS: Remembers testimony which indicates that this will become a fact of life as more and more loggers go out of business. TAPE 33, SIDE A 014 CHAIR HAYDEN: In some situations it seems that state and federal policies are forcing some of the loggers out of business. VOTE: In a roll call vote, all members present vote AYE. ROBERTS, BAKER, MILNE, NORRIS PARKS, and CHAIR HAYDEN vote AYE. REPS. WYLIE and HOSTICKA vote NO. CHAIR HAYDEN: The motion CARRIES. REP. CALOURI will lead discussion on the Floor. Staff measure summary submitted on HB 2533 (EXHIBIT R). HB 2534 - WORK SESSION 017 ADKINS: Reviews bill from (EXHIBIT S).

029 REP. ROBERTS: Why does the adoption of an unincorporated area start with the city and not with the county commissioners?

032 ADKINS: This is a different process which begins with the city. The current process does require an agreement by the Board of Commissioners and becomes a governmental agreement between the city and the county.

050 REP. HOSTICKA: Does the Legislature have the power to order a governing body to take an action?

055 ADKINS: Thinks that when the city does establish an urban service boundary this is the process that will have to be used.

067 CHAIR HAYDEN: What would the committee like to do, at this time, with the bill.

070 REP. WYLIE: Would like to work with the bill in committee. 075 REP. ROBERTS: Wants to know why the city is involved with something which is outside of their jurisdiction?

079 REP. BAKER: This is an area within the urban growth boundary however, the city wants to prepare now for future growth. We are setting up a

process before that happens.

103 REP. ROBERTS: Where is it written that areas have to expand?

113 CHAIR HAYDEN: We have a proponent and an opponent of the bill in the audience, do you want to hear from them or refer the bill back to

committee?

115 REP. ROBERTS: Would like to have the bill referred back to the subcommittee

118 REP. PARKS: Feels that the bill has been explored enough and would rather have the discussion take place on the Floor.

MOTION: REP. PARKS: Moves that HB 2534, AS AMENDED, be sent to the

Floor with a DO PASS recommendation.

135 REP. NORRIS: If you create an urban services boundary, does that mean that sewer and water service can be extended before the city is

incorporated.

141 ADKINS: Service is not extended to that boundary.

143 REP. NORRIS: Will it permit the city to extend services to that area?

144 ADKINS: Not without an annexation or an inter-governmental agreement between districts. 197 REP. HOSTICKA: Is it constitutional to allow individuals who are not residents of a city to give them the right to vote in an election which is being held by the city? 214 ADKINS: The county holds the election and the city pays for it. 217 REP. ROBERTS: If it is going to affect people in the county, they should be able to vote if not, they should not be able to get involved with the issues. 221 REP. HOSTICKA: Does not know if this mechaniSM is a constitutional way of doing that. 239 REP. WYLIE: Will support the bill. VOTE: REPS. MILNE, NORRIS, PARKS, ROBERTS, WYLIE, BAKER and CHAIR HAYDEN vote AYE. REP. HOSTICKA votes NO. CHAIR HAYDEN: The motion CARRIES. REP. CALOURI will lead discussion on the Floor. Staff measure summary submitted on HB 2534 (EXHIBIT T) HB 2324 - WORK SESSION 305 ADKINS: Reviews bill from (EXHIBIT U). 320 REP. PARKS: Are the parking spaces clearly marked? 322 ADKINS: Yes. >Discusses concern of the Oregon Paralyzed Veterans of America from (EXHIBIT V). MOTION: REP. ROBERTS: Moves that HB 2324, AS AMENDED, be sent to the Floor with a DO PASS recommendation. VOTE: In a roll call vote, all members present vote AYE. REP. EDMUNSON is EXCUSED.
