REP. HOSTICKA: Appropriations committee has mentioned twenty million dollars beyond the Governor's budget is needed...Will that fill up these beds?

208 REP. HAYDEN: The bill originated in Malheur Co. but would apply to any county, any facility in the state.

REP. HOSTICKA: Would like some clarity

228 REP. ROBERTS: We need to have some fair way of charging.

CHAIR HAYDEN: As long as the beds are empty we can make money.

REP. ROBERTS: Fair treatment for both state and counties concerning financial arrangements.
