052 JULIE DOW, RESEARCHER: Reviews bill (EXHIBITS J & K)

080 MOTION: REP. ROBERTS MOVES HB 3149 (-6) AMENDMENTS

REP. MILNE: How was it determined that the utility shall not use more than 16 percent for administrative expenses? In addition, the state forester shall not use more than 16 percent for administrative expenses? That seems a little high.

090 REP. NORRIS: We pulled that 16 percent out of the lottery library...it's arbitrary, but it says "not more than." It's a ceiling, not a goal.

094 REP. MILNE: That's a total of 32 percent...that doesn't seem to leave much...

REP. NORRIS: State foresters can get into more than paper shuffling--there could be technical assistance, education, some active

participation in some of these programs. It's not just classical overhead.

101 CHAIR HAYDEN: REP. NORRIS, would public utilities be under the supervision of the Public Utilities Commission? If in using this 16

percent they were garnering more revenues than they needed, wouldn't the PUC just adjust their rates?

105 REP. NORRIS: I'm reasonably satisfied that could happen.

CHAIR HAYDEN: REP. MILNE, does it raise your comfort level to know that people would be giving this 32 percent administrative expense are doing this voluntarily?

117 REP. MILNE: I think there is merit to the idea; if people want to make contributions, that's admirable. There's always a question of how much

is going to the true cause. REP. NORRIS: That's one of the reasons we ended up with the sunset

clause in the thing. We're plowing new ground and if it doesn't work we'll modify it.

127 CHAIR HAYDEN: What does Red Cross use as percentage for administrative expenses?

REP. BAKER: We'll come back and reassess this matter in six years or three sessions.
