CHAIR HAYDEN: Calls meeting to order at 11:15 a.m.

WORK SESSION HB 3181

JANET ADKINS, COMMITTEE ADMINISTRATOR: Describes HB 3181; submits (-2) amendments and informative material (EXHIBIT A).

035 REP. HOSTICKA: Asks about city size clarification.

JANET ADKINS: Responds.

045 REP. HOSTICKA: Will someone be testifying in favor of these amendments?

CHAIR HAYDEN: I don't think so.

REP. HOSTICKA: I'm wondering if the intent here is to give the cities the option to use their services and pay fees or if it just to say they don't have to pay fees and then if they use the services the rest of the people in the county have to pay for it - is this drafted incorrectly?

057 JANET ADKINS: Asked the speakers office two questions: Do they want to include fees and assessments both or just assessments?, and they wanted to include both service charges and assessments; and if they wanted these smaller cities to be completely out of the jurisdiction of the boundary commission and that wasn't what they wanted in the bill.

PUBLIC HEARING 3181 Witnesses: Steve Gordon, Lane Co. Boundary

Commission 078 STEVE GORDON, LANE CO. BOUNDARY COMMISSION: Testifies in opposition; submits written testimony and informative material from James A Saul. (EXHIBIT B) 142 REP. ROBERTS: How do you make a determination of what the fees are going to be? Isn't that set down in statute? GORDON: Yes it is. The amount that we charge is not. REP. ROBERTS: Then how do you make a determination on who is going to pay? GORDON: Under the statute all cities are assessed based on population. 153 REP. ROBERTS: Would a Springfield person pay the same per person as Eugene? GORDON: Yes. 167 REP. EDMUNSON and GORDON: Discuss the fee amount comparison between cities. REP. EDMUNSON: Of the proposed fee assessment of \$485 to Junction City, does that pay for the staff time if Junction City had to process these themselves? GORDON: No. REP. EDMUNSON: Why would Junction City support abolishing its arrangement? GORDON: The issue in Junction City is a philosophical one. HB 2339 - PUBLIC HEARING Witnesses: Sharon Schrenk, Farm Operator Walter Eichler, Corvallis Farmer 191 JANET ADKINS: Describes HB 2339; submits (-2) amendments and informative material (EXHIBIT C). 260 REP. HOSTICKA: Do vehicles over 80,000 pounds usually operate in tandem and under special permit anyway? JANET ADKINS: Not the farm plated vehicles currently, but any other truck over 80,000 pounds is here under special permit. 275 SHARON SCHRENK, FARM OPERATOR: Testifies concerning of HB 2339; submits written testimony (EXHIBIT D). 394 WALTER EICHLER, CORVALLIS FARMER: Testifies on HB 2339. - Talks about expenses. TAPE 44, SIDE A 034 EICHLER: Talks about drug testing. SCHRENK: Talks about drug testing. 044 059 REP. EDMUNSON: Asks witnesses to explain what changes would improve

the amendments. EICHLER: Concerned about wanting to have trucks carry over 80,000.00 lbs. 087 SCHRENK: Talks about weight of truck issue. 095 REP. ROBERTS: The weight is set because of the wear and tear on the highways and streets; you need to have a special trip ticket if you go over 80,000 pounds. - these amendments are as good as it will get. will only support amendments as they are.
