114 REP. EDMUNSON: I am concerned that putting this on the ballot, and if it would fail, would add implicit support to the argument that the

constitutional language guaranteed a sixteen percent gross of lottery proceeds for the administration of the lottery, whereas now I do not believe that that's what the constitution says, and if we were to put this before the people and it was rejected, then I think we are backing off and saying "we don't think that the constitution says what we thought it said either." I think this weakens the position that I've reached that the constitution allows us as legislature to have budget oversight and to approve the budget of the lottery, and we are not

required to dedicate sixteen percent to the lottery administration, but the constitution only says that at least eighty-four percent shall be

returned to the public, and the remaining sixteen is not spelled out in the constitution.

146 REP. BURTON: This is probably one of the most detailed amendments that we have in the constitution. - on the political question, there is always a risk that you can lose at the polls, my guess is that an initiative on the ballot that says that

there will be an ability to control these administrative costs, because of the publicity this has been given, would probably pass very easily.

182 REP. EDMUNSON: I intend to vote for this, our support for this measure does not in any way suggest that we question the authority that this

assembly has to oversee the budget of the lottery commission.

205 REP. BAKER: Does the governor have the authority to fire the lottery commission?

REP. BURTON: Gives example.

REP. BAKER: Could the executive of the state diSB and this commission and reappoint people that had the specific directive from the governor that they would open up a lottery to full accountability?

230 REP. BURTON: I believe that is correct, yes.

REP. BAKER: Has there been any effort made to ask the governor to do

exactly that?

REP. BURTON: Based on other states' experiences, I've asked the governor's office to examine the contracts and decided how we're to

proceed with those. So far this has been on an informal basis. We're having a difficult time getting information from the lottery office, despite several inquiries...
