183 Chair Parks asks George Veer whether it is clear that this bill only affects the state and not counties or cities 220 > Rep. Norris asks how public agencies recover costs. It is explained in statute, codified in 192.440, that public agencies have the right to charge for the cost of retrieving the information

296 Administrator Adkins suggests that on line 11 "person" be substituted for "company"

MOTION: Chair Parks moves that the aforementioned amendments BE ADOPTED

VOTE: Hearing no objection the motion CARRIES. Reps. Edmunson and Wylie are excused

320 Rep. Norris asks whether the state benefits from the language in Section 5 of the amendments. No

340 MOTION: Rep. Milne moves that the -2 amendments minus section 5 BE ADOPTED

VOTE: Hearing no objection the motion CARRIES. Reps. Edmunson and Wylie are excused

MOTION: Rep. Milne moves HB 2221, as amended, to the full committee with a DO PASS recommendation

MOTION: Rep. Milne moves HB 3055 to the full committee with a DO

PASS recommendation

Discussion: > Rep. Parks states that the public is the best watchdog and that he

does not support the bill

VOTE: In a roll call vote Reps. Milne and Wylie vote AYE, Rep.

Hayden and Chair Parks vote NO and the motion FAILS

MOTION: Rep. Milne moves that HB 3055 be re-referred to the full committee WITHOUT a recommendation to passage

VOTE: Hearing no objection the motion CARRIES
