HB 3623 - WORK SESSION

JANET ADKINS, COMMITTEE ADMINISTRATOR: Request by the subcommittee chair  
to refer HB 3623 to the full committee.

005 MOTION: REP MILNE MOVES THAT HB 3623 BE MOVED TO THE FULL  
COMMITTEE WITHOUT RECOMMENDATION

VOTE: IN A ROLL CALL VOTE THE MOTION PASSES. ALL MEMBERS VOTING AYE.

HB 3151 - PUBLIC HEARING

033 REP WALDEN, DISTRICT 56: Testifies in support; submits -3  
amendment (EXHIBIT A), submits political disclaimer (EXHIBIT B), submits  
agreement form for political broadcasts (EXHIBIT C).

081 COLLEEN SEALOCK, SECRETARY OF STATES OFFICE: Testifies in  
explanation. The language that this amendment recommends exists  
for federal

candidates but does not exist for the state candidates. - The sub 2 -C  
would be a new requirement, and may require a fiscal

impact statement.

REP EDMUNSON: How would that create a fiscal impact?

SEALOCK: If all that statement means is that the authorization has to be by the individual group that would run it, there would be no fiscal impact.

REP EDMUNSON: Where would the fiscal impact for the State of Oregon come, if a disclaimer were required?

SEALOCK: It would just be another opportunity to have someone not follow it, so there would be the opportunity for more potential complaints.

SEALOCK: It would be a minimal fiscal effect.

123 REP WYLIE: If a group runs an add on somebody else's behalf and they didn't authorize it, I think it is important information to the public

to know that it was an unauthorized ad. - When you say a minimal fiscal impact, would that be one or two

thousand dollars a year?

SEALOCK: Yes, it would probably be something we would absorb in our own budget.

HB 3151 - WORK SESSION
