(11:10 a.m.) HB 2632 - WORK SESSION JANET ADKINS, COMMITTEE ADMINISTRATOR: Describes HB 2632, submits amendment (-3) (EXHIBIT A). CHAIR PARKS: The counties will add as footnote on a meeting notice and in Jackson county's case they will save about one thousand dollars a year. MOTION: REP. WYLIE MOVES THAT HB 2632 BE SENT TO THE FULL COMMITTEE WITH A DO PASS RECOMMENDATION VOTE: IN A ROLL CALL VOTE THE MOTION CARRIES. ALL MEMBERS VOTING AYE. MEMBER EXCUSED: REP. EDMUNSON. CAROLYN ADAMSON: This does not change the bill for Cannon Beach. 090 AL YOUNG: Testifies in support; the amendments go a little bit further in defining when a person could get a permit; We are willing to work with committee.

159 PETER TOLL, DIRECTOR OF GOVERNMENT AFFAIRS: Testifies in support; Newspaper publishers concerned with the integrity level in printed

materials, we want to make sure that Oregon maintains it reputation for a clean operating legislature and a clean operating government is

sustained through passage of this bill.

202 TODD JONES, SECRETARY OF STATE'S OFFICE: Testifies. - Question of penalty - This does not currently forbid a candidate from making an agreement

with a endorsing body - What if a body agrees to endorse me and prints 20 or 30 thousand

copies of that publication, what if I "wink, wink - nod, nod" and tell

them I won't pay for this endorsement but I might happen to go out and

buy 30 thousand copies of your publication and mail it to my

constituents.

255 REP. MILNE: The bill just reinforces what current law is?

JONES: The key change is that the words "editorially support" are being removed replaced with "endorsement".

REP. MILNE: So this is clarification and broadening.

281 JANET ADKINS: The bill also changes "periodical" to "publication" - does publication cover a post card?

JONES: The word publication does not replace the word periodical, the

word periodical remains.

292 TOLL: A publication is something that is printed specifically in a standardized format with a standard approach.

REP. WYLIE: This gets us as close as we can go without getting into

first amendment rights.
