007 CHAIR PARKS: Calls the meeting to order at 9:23 a.m.

HB 3361 - PUBLIC HEARING

(EXHIBIT A) - fiscal analysis (EXHIBIT B) - ORS information

011 BILL NICKLEBERRY, DEPARTMENT OF GENERAL SERVICES: Continues testimony from 5/4/93 hearing. Reviews six steps pertaining to sale of state

lands.

075 REP LARRY SOWA, DISTRICT 26: In 1987 we got a bill in the agriculture committee that said that certain rural lands that are owned by the state would be available if they were in small parcels to be sold and the

general policy would be to sell them to the surrounding land owners. Some of us where concerned that we could lose some value for recreational uses of those lands or access to other recreational uses, so we talked to the Division of State Lands and others and said we want you to go through a process where you identify all the values of those lands before you sell them. In the meantime that statute has been interpreted that it would include all state lands and that was not our intent. 104 REP WYLIE: Does the notification go to just the city officials and planning department, how is that notification sent?

111 NICKLEBERRY: We go to the cities and ask where they want notification to go, but in some of the small rural areas it could be a board of

commission for the counties, etc.

116 REP. WYLIE: Does the property go to the highest bidder or does that city get some priority?

124 NICKLEBERRY: It would go to highest bidder, if it is past the deadline for notification to be received from the political subdivision.

127 WYLIE: Does it ever happen that way, where the city gets a delayed response, where they get interested in it because of community interest?

130 NICKLEBERRY: The situation that I am aware of is the Callahan Center in the City of Wilsonville.

HB 3623 - PUBLIC HEARING

148 JANET ADKINS, COMMITTEE ADMINISTRATOR: Reviews bill (EXHIBIT C)

161 REP TIERNAN, DISTRICT 24: Testifies in support of HB 3623; - We need a quick easy reporting system.

258 CHAIR PARKS: In sub-section 2 of section 2, line 22-24, What is different in comparison to what they do now?

268 REP TIERNAN: Nothing is different, except that when they get a phone call or written complaint, instead of waiting for the annual audit they have an affirmative obligation to look at situation on the spot.

278 CHAIR PARKS: Why did you pick the Secretary of State rather than the Attorney General to do an investigative function?

283 REP TIERNAN: It was my guess that the Secretary of State with the auditing functions they have now, was the place to put it. I think the

fact that the job gets done is the issue and exactly who does it is less important.

293 CHAIR PARKS: The thread of your bill is that based upon the investigation and some kind of a determination of fraud, waste or abuse having occurred then the glare of publicity will be enough to deter it? 299 REP TIERNAN: The report going back to the agency head would take appropriate action to make sure that it did not happen again or recoup

dollars etc.

308 REP MILNE: Nothing in the bill protects people, is there anything in the bill that people will feel comfortable calling the hotline, will

they be anonymous?

320 REP TIERNAN: The way hotlines usually work is that you are assigned a number, you will not have to give your name and you can use your number as your reference for follow-up information.

334 REP MILNE: It is obvious that there is that fear, if you are a state employee and you are aware of excessive spending etc., you are not as

likely to report it unless there is some assurance of confidentiality.

342 REP TIERNAN: I think we will see that most callers will be state employees.

355 REP WYLIE: I think a non-retaliation and protection amendment makes sense. I am interested in cost and follow-up.

407 REP TIERNAN: Defines Fraud, Waste and Abuse; Can send letter instead of calling. You need to make it easy.

083 CHAIR PARKS: It seems in my office that people do not hesitate to call and report complaints. If anonymous it allows for abuse,

confidentiality is the way to protect. Reviews fiscal impact statement (see EXHIBIT C)

122 REP TIERNAN: The cost could go higher; Need to weigh the benefit and detriment.

153 CHAIR PARKS: Secretary of State investigates in a civil nature; Should be a criminal investigation process.

174 REP TIERNAN: Main intent of the bill is to uncover waste and abuse in government.

186 REP MILNE: A complaint, criminal in nature, should be turned over to proper authorities.

217 NINA JOHNSON, SECRETARY OF STATE'S OFFICE: Testifies; - Fiscal impact would be higher; - We would hope that if this bill is sent out of this committee that

there would be a review of what would be required of our office.

257 DON WAGGONER, DIRECTOR OF AUDIT, SECRETARY OF STATE'S OFFICE: I am familiar with the ombudsman program and how they work.

259 CHAIR PARKS: How many do we have?

260 WAGGONER: I am not sure of how many in this state.

261 CHAIR PARKS: Isn't that one of the functions they are supposed to do?

262 WAGGONER: Yes it is, it is usually set up as some type of a government waste hotline.

265 CHAIR PARKS: Could you get me a list of who the people are, so we can see how many there are and maybe we could get some insight on how much

of this they are already doing.

270 JOHNSON: As the citizens representative, I need to get together with them and look at their volume of calls.

283 WAGGONER: Testifies; - I would like to have the chance to institute a public relations

program for the audits division. - Make it known at the beginning of each audit that we are auditing a

program or agency, the time period that we are auditing, any particular aspect of that audit that needs to be released in the media and also

invite citizens to call us with any information that they believe would be relevant to our audit.

322 CHAIR PARKS: Why don't you talk with Rep. Tiernan about your idea.

326 WAGGONER: We have already done that but we can continue our discussion.

351 MARY BOTKIN, American Federation of State, County and Municipal Employees: - Who determines what is waste? - Prefer system now in place - call Secretary of State's office.
