145 NORM MANSELLE, GENERAL SERVICES: Intent was to provide parking for disabled employees in compliance with ADA - Lose revenue to allow area disabled parking space - Priority assignments for current disabled employees - Put other employees on waiting list for parking - Reserved space is \$ 45.00 in Salem - Support amendments worked on with City of Salem - Answers questions from members

166 BROWN: Parking enforcement can only access records through Data Automated Voice Exchange (DAVE)

212 TAYLOR: Law Enforcement Data Systems (LEDS) is a way to access information - Answers questions from the members

235 CHAIR NORRIS: Directs DMV to begin putting numbers needed by law enforcement on the front. - Asks all interested parties to meet and make lines of communication clearer - Directs DMV administration to resolve this issue without the need of a new law
