REP. MEEK: Is this a mandate or recommendation?

LAURIE SCHWARTZ, SDSD, PROGRAM TECHNICIAN: Responds to Rep. Meek that the disabled originally wanted its own division. Because of funding the seniors and disabled were merged

REP. MEEK: How about allowing options for the agencies to have separate or merged councils, instead of a directive?

SCHWARTZ: Responds

STONE: If there were a consolidation, it would need to be on an equal basis.

CHAIR FORD: Could you ask the AAA how they would feel about Rep. Meek's suggestion?

STONE: Yes

150 REP. FISHER: Supports Rep. Meek's suggestion

REP. DELL: We need to define which groups would need to reach agreement 188 REP. SHIELDS: Two groups can come together and reach agreement

200 TED STEVENS, LANE COUNTY AAA: Testifies in favor of HB 2150. Views this as a clean-up bill. This bill does not appear to have a fiscal impact

REP. MEEK: Senior councils are having a hard time with disabled regulations -Sees direct cost in implementing this bill

STEVENS: There is already a disabilities council with staff who will work with me when a merge occurs -We anticipate areas where councils will work closely together; there may be a reason in the future for the groups to sit together on issues

PUBLIC HEARING - HB 2151

Staff submits ORS 410.410 (EXHIBIT H)

300 JIM WILSON, SDSD: Submits testimony and testifies in favor of HB 2151 (EXHIBIT G)

REP. MEEK: This bill changes the thinking of OPI and I cannot support this philosophical change

REP. FISHER: The greatest independence is being able to pay your own way

TAPE 18, SIDE A

PUBLIC HEARING HB 2150

040 EUGENE ORGAN, OREGON DISABILITIES COMMISSION: We support the legislation, as written -Concerned that a council exists, at the local level, for policy decision effecting both populations -- this bill allows for the disabled population to have a council to meet with other folks with disabilities in their community to find out what their

needs are etc. The senior population and the disabled population have very different needs

062 ACTING CHAIR STEIN: Would it be acceptable to have an option in the law that would allow a joint council?

ORGAN: Proportional representation becomes a problem -Tells how joint councils have worked in the past -Two councils are supported because of proportional representation issues.

070 LEE HAZELWOOD, GOVERNORS COMMISSION ON SENIOR SERVICES: We have had the disabled in our advisory council; they participate but they want their own advisory council -- we do liaison with one another - The disabled have special needs; the elderly have separate special needs
