the social programs, but it also establishes a dangerous precedent that violates patient confidentiality -Ten citations of statutes regarding confidentiality of records in the

bill, removing protection of patient's records -Patient confidentiality must be protected -Urges look at each statute relating to confidentiality -Questions the need for the bill

165 REP. FORD: Need clarification from Attorney General's office -needs should be defined

190 REP. DELL: Suggests addressing each statute with provisions and exclusions

PATTERSON: Has no prepared amendments. -Each statute needs to be considered on it's own merit -The bill is too broad

005 REP. VAN VLIET, CHAIR: Opens the informational meeting.

MARK GREENBURG, NATIONAL CENTER ON LAW AND SOCIAL POLICY: Works 012 for the Center on Law and Social Policy, a nonprofit group that focuses on issues that affect low income families. Greenburg's focus is on welfare reform on the state and national level. Key Points: -Developments in Washington D.C. surrounding 1) the new administration and 2) welfare at the federal level. - Developments in state initiatives in the past year. 034 Explained the national outlook on welfare. 043 Discussed the Clinton/Gore book on putting people first. 047 "Make work pay" plan. Suggests that if a family has someone working full time, they should not be poor. * Expanding the earned income tax credit at the federal level. * Creating a minimum wage that is indexed for inflation. * Stronger child support enforcement. * Health care for all Americans. 059 Putting people first. Two-part Clinton plan. 1) Significant expansion of education and training during the first two years that a family receives Aid to Families with Dependent Children assistance. 2) Create an expectation of work in the public and private sector. 089 Recent developments: Creation of a ten-member task force to work with the Clinton administration to formulate a proposal. 103 Describes how the Clinton plan will affect states in the future. 109 Key Concerns of the Clinton Plan: Creating a program that can work within current state budgets. 116 There is consensus that whatever needs to be done needs to build on what the states have done in the Federal Family Support Act.

121 Clinton supports building on the work of the Federal Family Support Act.

131 Other states' developments. Book summarizing states' accomplishments, The Rush to Reform. There doesn't seem to be one common theme. Behavioral initiatives: Linking welfare received to school attendance, etc. Work on the relationship between welfare assistance and working poor families. AFDC system takes assistance away from working families.

209 Most states are trying to adjust the welfare system to act favorably on families trying to become employed.

228 Another theme: Does the welfare system support two parent families. Equally needy children have been denied assistance due to two parents in the home.

244 Another theme: Concern about how the welfare system treats families that attempt to save.

Iowa: Working on changes in welfare rules on families that work, 271 two parent families, asset rules. Also working with the individual development accounts: A type of savings account that pays for education, business, house, etc. 299 There is enormous consensus that the current system doesn't work. 309The challenge is figuring out how to move the system forward. 318 REP. VAN VLIET: Asks about the Iowa bill and federal waiver approval. 320MR. GREENBURG: Comments that the Iowa bill has not yet passed, but there seems to be enormous consensus for the bill. Discussed federal waiver grants. 365 REP. FORD: Discusses general workfare programs that require all individuals on welfare to work. 377 MR. GREENBURG: Discusses Community Work Experience programs and the success of workfare type programs. Shift from the human capital emphasis to a stronger focus on education. REP. FORD: Asks about the definition of education in the common 438 work experience programs. 442 MR. GREENBURG: Discusses high school completion, education of teen parents, and allowing access to post secondary education.

060 SEN. TIMMS: Interested in workfare statistics among different states. 066 MR. GREENBURG: Hard to get reliable statistics. 074 SEN. TIMMS: Is the program working in the states that are using? 075 MR. GREENBURG: In the 80's there were some experiments in workfare-like programs that have shown raised employment rates, but not an increase in earnings. 109 Workfare itself has only been tested once in West Virginia. In this test there was not much difference between the earnings of the control group and the test group. It is hard to tell because of the area of the test was rural and depressed at the time. 132 Greenburg will make his research summary on workfare available. 143 SEN TIMMS: Discusses the workfare issue further. 169 MR. GREENBURG: Workfare may be beneficial to those who have no work history. Most welfare individuals do have a work history, this is not a population that has never been exposed to work. 208 SEN. COOLEY: Discusses the increase of individuals receiving welfare from those in urban areas to those in smaller rural areas that are unable to support these individuals. No work opportunities in the rural areas. Puts a strain on the counties. 228 MR. GREENBURG: This has happened elsewhere. They are moving to areas where housing is cheaper, but job opportunities are limited. 240 Cooley and Greenburg discuss the topic further. 261 ART WILKINSON, LEGISLATIVE ANALYST: Interested in welfare waivers that other states are considering. 270 MR. GREENBURG: The most common is the 100 hour rule. Discusses this type of waiver. 334 REP. SHIELDS: Requested data on states that have dropped the 100 hour rule. 343 CARLA SPENS, AFS CONSUMER: Concerned about the 100 hour rule. 366 MR. GREENBURG: Discusses the \$30 and 113 continuation disregard. Discusses waivers. Discusses AFDC rules regarding self sufficiency VICKY FIELDS, EMPLOYMENT DIVISION: Interested in the efforts. 478 child care issue. State run child care programs. TAPE 1, SIDE B 042 MR.
