problem. Refers to Gang Response Plan. (Exhibit A)

092 DETECTIVE DICK STEIN, OREGON STATE POLICE YOUTH GANG STRIKE FORCE: Testifies on the scope of the problem. Describes composition of gangs.

124 REP. LUKE: Discusses gang members outside of the Tri-County area.

128 STEIN: Talks about gang activity outside of Multnomah County. Discusses the education process for police officers.

147 CHAIR FORD: Asks about the purpose and motivation for these gangs in the outer lying areas.

150 STEIN: Discusses profit motivation and the drug trade. Discusses turf disputes.

171 SHIELDS: Asks about the spread of gangs who are not profit oriented.

252 REP. FISHER: Asks for clarification on the House of Amosia.

253 GAGE: It is a residential program that provides outreach services, as well as drug and alcohol treatment. The program also works with

employment possibilities.

278 ALONZO GRAVES, PARTICIPANT IN AMOSIA PROGRAM: Discusses the myth that drug dealers can't be rehabilitated. Discusses the need to deal with

the kids as human beings, and not "gang members". Explains the bonding

and the friendships that need to be dealt with when working with gangs.

342 REP. SHIELDS: Discusses changing perceptions of gang members.

404 GRAVES: Explains the need for personal contact with the youths. You can't understand a person that you know nothing about.

433 DAN TABAZON, NIKE: Discusses the employment program at Nike. Discusses community concerns, and the company's commitment.

075 FRANCISCONNI: There is some funding currently, but we are waiting to hear about more. The model is working, but we need the resources to

provide more jobs.

107 RODNEY COOK, CHAIR OF CLACKAMAS COUNTY YOUTH GANGS TASK FORCE: Discusses the importance of coordination and collaboration between the

communities.

128 ROB KAPPA, CLACKAMAS COUNTY YOUTH GANGS TASK FORCE: (Exhibit D) Submits and reviews testimony dealing with gangs.

200 CHARLES MANSFIELD, MILWAUKIE CHIEF OF POLICE: Discusses partnerships with other police departments, to combat the gang problem. Discusses

the need for developing kids life survival skills.

262 REP. LUKE: Asks about differences in gangs today, compared to gangs in the past.

270 MANSFIELD: The gangs are formed differently today. The reasons for association have more weight to them. They are support groups that feed on the members of the group.

309 COOK: Discusses raciSMand skinheads.

344 FISHER: Discusses the violence and savagery in the gang activity recently.

362 MANSFIELD: There is no reason for a lot of the violence. They may not like the way you act, dress, or look. They just want to prove a point.

The acts are senseless.

377 KAPPA: Discusses the importance of getting the word out. Talks about the need for more information sessions.

413 RANDY GRAVES, DIRECTOR OF THE BOYS AND GIRLS CLUB: Testifies on the activities the Boys and Girls Club are involved with to help fight gang activity. Discusses the preventive programs.

108 NORM MONROE, MULTNOMAH COUNTY: Discusses the Gang Response Plan. Explains that the problem is caused by unhealthy communities. Discusses the importance of nurturing communities. 169 CHARLES FORD, NORTHEAST COALITION: Discusses the Youth Gangs Outreach concept. Discusses the importance of a statewide effort.

228 WILLIE BROWN, NORTHEAST COALITION: The answers to the gang problems lie in the communities. Emphasizes the importance of the programs that deal with the young people. 260 REP. LUKE: Asks about the difference between kids today and kids in the sixties and seventies.

264 MONROE: Community played a bigger role in the development in the children. Families held higher values.

309 SHERRI CALOURI, CHAIR OF BEAVERTON SCHOOL BOARD: Discusses budget restraints that result in problems preventing gang activity. Discusses

educational needs to deter gang formation.

372 TIM ALEXANDER, WASHINGTON COUNTY JUDGE: Discusses preventative government. Discusses penalties when dealing with gang members. Talks

about putting money in the front end of the system (probation officers), rather than the end product (jails).
