CHAIR FORD: Calls the meeting to order at 10:15 a.m.

HB 3308 - Work Session

012 REP DELL: submits and reads written testimony (EXHIBIT A) -Human
Investment Strategy -Investing with accountability for results -Customer
centered service systems -Partnerships to leverage resources 065
-Human Investment Budget 090 -Other legislation relating to Human
Investment

133 REP EIGHMEY: testifies in support of HB 3308 -this is a
non-partisan issue

160 MIKE MARSH, EXECUTIVE DEPARTMENT: \$500,000 fiscal impact
(EXHIBIT B) -the Executive Department will go ahead with this

190 CHAIR FORD: suggests eliminating section 4 of -2 amendment
(EXHIBIT C)

220 MARSH: This will work without the money if SB 1130
passes, the Government Productivity Act 250 -Sub 3: "the Investment
Budget shall consider investments in", it would be the legislature's
intent that we select from those areas with the

most value within available resources, and have a couple of agency budgets selected, not necessarily from every category

260 REP SHIELDS: the money could be generated by synergism

285 CAROLYN LANDIS, COMMUNITY ACTION DIRECTORS OF OREGON: testifies in support HB 3308 -accountability -a human services plan would be helpful to determine the most successful outcomes -evaluation of providers and community developers -empower people for achievement with a judicious combination of

expectation and assistance -policy and economic implication of the bills are positive

310 MICKEY CLAY, LUTHERAN OFFICE ON PUBLIC POLICY: testifies in support of the bill -discusses Oregon Benchmarks

345 CHUCK SHEKATOFF, OREGON HUMAN RIGHTS COALITION: supports addition on line 11 of the amendment, Section 2, subsection 2: "including tax

expenditures" -supports section 2, paragraph 4 that requires budget reductions that

will affect the Oregon Benchmarks

375 TIM HOUCHIN, OREGON PROGRESS BOARD: the Board supports the bill the bill is consistent with the Human Investment Strategy and working toward achievement of the Oregon Benchmarks

TAPE 188, SIDE A

005 MOTION: Rep Dell moves the -2 amendments

REP DELL: explains changes to the amendments: -line 15 of existing bill, remove lottery funds -line 18 of original bill, remove the word, "budget" -line 26, remove "but not limited to" language -line 30 of original bill, add "community infrastructure" -line 22 of original bill, "including tax expenditures"

039 REP LUKE: definition of "environmental quality"

052 VOTE: Hearing no objection, the motion carries

055 MOTION: Rep Dell moves the amendment of the original bill by removal of section 4, in concept, from the original bill

063 REP SHIELDS: suggests including value statement in the bill

095 REP LUKE: changes can happen in the senate

105 REP DELL: encourages synergism

115 REP SHIELDS: would like to be included in discussions on the bill on the senate side

120 VOTE: Hearing no objection, the motion carries

MOTION: Rep Dell moves the referral of HB 3308 to Appropriations be rescinded

VOTE: Hearing no objection, the motion carries

MOTION: Rep Dell moves that the rules be suspended to allow for immediate consideration, without the LC amendments

VOTE: Hearing no objection, the motion carries

126 MOTION: Rep Dell moves HB 3308 as amended to the floor with a do pass recommendation

VOTE: In a roll call vote, the motion carries with all members present voting AYE. Rep Meek is excused

Rep Dell Will carry the bill

HB 3309 - Work Session

145 MELANIE ZERMER, COMMITTEE ADMINISTRATOR: -explains -2 amendment (EXHIBIT D) -clarifies that plan shall be a part of the state's bigger human

investment strategy -deletes requirement that work group will work with the Executive

Department on HB 3308 -adds charge of developing safety net plan for people never intended to be part of the work force -allows work group to develop plan that looks beyond one biennium

180 CHUCK SHEKATOFF, OREGON HUMAN RIGHTS COALITION: supports the amendment, then the bill as amended

185 TIM HOUCHIN, OREGON PROGRESS BOARD: the board supports HB 3309 and the -2 amendment

199 MOTION: Rep Dell moves the adoption of the -2 amendment to HB 3309

VOTE: Hearing no objection, the motion carries 204 MOTION: Rep Dell moves HB 3309 as amended to the floor with a do pass recommendation

VOTE: In a roll call vote, the motion carries, with all members present voting AYE. Rep Meek is excused

Rep Ford will carry the bill

SB 484 - Work Session

230 ZERMER: reviews previous amendments -summarizes -A6 (EXHIBIT E)

265 BRIAN DELASHMUTT, OREGON NURSES ASSOCIATION: supports the -A6 amendments

275 CHUCK GRESS, OREGON STATE PHARMACISTS ASSOCIATION: opposes the -A6 amendments -opposition to repackaging drugs for dispensing by

nurse practitioners -pharmacy should purchase and be involved in dispensing the drugs 300 -there are professional and safety arguments as well as economic issues

340 DELASHMUTT: the -A6 amendment is a technical clarification of the -2 that already passed out of this committee

350 REP SHIELDS: concern about bill's performance on house floor

370 GRESS: Opposes the bill, but will accept the -3 amendments, limiting the drugs to the four categories

TAPE 187, SIDE B

005 REP LUKE: discusses the -3 amendments limiting the ability of rural practitioners to dispense drugs in four classifications

015 DELASHMUTT: it does not limit dispensing

020 MOTION: Rep Eighmey moves the -6 amendments

REP EIGHMEY: the -6 includes all attempts for limitations, safeguards, and precautions in the bill. However it is the concept that is drawing objection.

043 REP FISHER: discusses the Board of Pharmacy licensing

VOTE: Hearing no objection, the motion carries

104 MOTION: Rep Luke moves the -3 amendments to SB 484

REP LUKE: explains the amendments

REP FISHER: statewide safety issue

REP FORD: prescription rights for county health departments

REP DELL: opposes -3 amendments

150 REP EIGHMEY: opposes the -3 amendments -the ORS provision should be standardized for all nurse practitioners -the pharmacists will not compromise

185 DELASHMUTT: financial accessibility

210 REP FISHER: insurance coverage of prescriptions

240 VOTE: In a roll call vote the motion fails, with Rep Fisher, Rep Luke, and Chair Ford voting AYE, and Rep Dell, Rep Eighmey and Rep Shields

voting NAY. Rep Meek is excused.

255 REP SHIELDS: issue of oral contraceptives -suggests compromise between ONA & Pharmacy Association

280 DELASHMUTT: the -3 amendments are the result of a three and one-half years compromise -the pharmacists are opposed to the bill in

concept

295 REP LUKE: issue of oral contraceptives

304 GRESS: discusses compromise -this issue is an encroachment on the pharmacist profession

317 DELASHMUTT: discusses broader legislation

335 MOTION: Rep Dell moves SB 484A as amended to the floor with a do pass recommendation

VOTE: In a roll call vote, the motion carries with Rep Dell, Rep

Eighmey, Rep Shields, And Chair Ford voting AYE, Rep Fisher and Rep Luke vote NAY. Rep Meek is excused.

Rep Eighmey will carry the bill

CHAIR FORD: Adjourns the meeting at 11:40 a.m.
