Staff submits HB 2296-4 proposed amendments (EXHIBIT A) and a fiscal impact statement on the proposed amendments (EXHIBIT B)

DIANA ROBERTS, CHILDREN'S SERVICES DIVISION (CSD): Discusses concerns about the -4 amendments: 1) the legislation, as written, may cause additional liability to CSD, and 2) on page 2 lines 5-9 we have concerns that the responsibility will fall on judges instead of medical professionals -These concerns are currently being reviewed

100 DIANE WARD, REP. FORD'S OFFICE: Discusses the -4 amendments -Discusses situation of foster child being prescribed psychotropic drugs

240 ROCHELLE CASHDAN, PH.D.: Testifies in support of SB 859-A -The bill is beneficial to those who need treatment and to the treatment system, it will build trust -Refers to page 4 of the bill -Points out that medical records are confusing and the "Declaration for Mental Health Treatment" form should not be "lost" in a person's file
