005 MELANIE ZERMER, COMMITTEE ADMINISTRATOR: reviews background of
the bill

written testimony on SB 786 (EXHIBIT A)

064 WENDY GRAVES, DENTAL LAB OWNER: SB 786 is a compromise -the
industry is already regulated -perspective of Oregon Association of
Dental Labs non-members

106 LLOYD ATHEARN, OREGON HEALTH DIVISION: clarifies role of
Health Division -neutral third party to appoint task force members -the
division has no position on the bill

138 REP DELL: the bill suggests that the purpose of the task force
is to study both the need and the justification for the state regulation
-emphasis on effort to resolve industry problems

165 GRAVES: the industry has made an effort to organize

176 MYERS: the ODA believes that the proper body to regulate labs
is the Board of Dentistry which is already authorized to act, if needed

092 DELL ISHAM, OPTICIANS ASSOCIATION OF OREGON: the -2 amendment would replace the original bill with the language that would allow a

dispensing optician to duplicate ophthalmic lenses upon presentation of the whole lens by the requestor

100 ZERMER: technical problem on the -2 amendment has been resolved -2 amendment (EXHIBIT I) -discusses issues

ISHAM: answers questions from the members

182 REP MEEK: suggests putting the Optician Association under the Board of Optometry

226 ANN STEINER BURKE: explains the amendment -relates perspective of dispensing optician

330 REP EIGHMEY: discusses liability issue

TAPE 225, SIDE B

BURKE: does not support the amendment

MOTION: Rep Shields moves to delete the word, "ophthalmic" on line 6 and the word, "spectacle" be added

035 REP DELL: suggests "any ophthalmic lens excluding contacts"

CHAIR FORD: restates motion -the word, "ophthalmic" is in and after the word, "lens" on line 6 add

"excluding contacts lens"

048 VOTE: Hearing no objection, the motion carries

074 MOTION: Rep Shields moves the -2 amendment to HB 2317 as amended by the committee

REP MEEK: discusses how the bill relates to other legislation

095 ISHAM: this bill addresses consumer choice -Opticians do not support the expiration date

110 REP DELL: discusses two year expiration date and consumer awareness

VOTE: The motion carries, Rep Meek objects

160 MOTION: Rep Shields moves HB 2317 as amended to the floor with a do pass recommendation

VOTE: In a roll call vote the motion carries with Rep Dell, Rep Eighmey, Rep Fisher, Rep Luke, Rep Shields and Chair Ford voting AYE. Rep Meek votes NO.

Rep Shields will carry the bill

SB 1063 - Work Session

185 REP MEEK: It is my understanding that the Oregon Medical Association (OMA) and the midwives have worked out some amendments

195 LAUREN MOUGHON, WOMEN'S RIGHTS COALITION: discusses possibility of creating a Board of Midwifery under the Health Division wherein the licensure would be voluntary. -the OMA does not want this board to be a part of the Board of Naturopathic Examiners -discusses appropriations possibility -willing to take part in possible work group

219 REP LUKE: has some objections to the bill -the bill would set an

undesirable precedent -describes elements of bill that would please everyone -registration system -eventual mandatory licensure

260 MOUGHON: discusses signing of birth certificates -wants as many midwives as possible to participate -time and outreach to encourage participation

299 REP LUKE: suggests setting goals

MOUGHON: discusses sunset review

319 KATE DAVIDSON: discusses eighty-five percent participation in two years -voluntary licensure is goal of midwives, with seventy-five percent compliance

354 BRIAN DELASHMUTT, OREGON NURSES ASSOCIATION: discusses OMA and ONA parameters: -Health Division instead of BME -composition of the board -minimum number of deliveries for certification -infant resuscitation and patient transfer -outcome data, registry -patient disclosure, no liability coverage by provider -"phased in" requirements: -certification for purposes of Medicaid reimbursement -monetary threshold -registry of those not certified

DELASHMUTT: the Governor has signed off on that issue

CHAIR FORD: will discuss with House leadership -the bill will be heard on Thursday

DELASHMUTT: discusses phase in and sunset date

114 REP DELL: clarification of eighty-five percent phasing in for licensure

REP EIGHMEY: supports the sunset review

159 DAVIDSON: discusses imposing regulation on midwives based on amount of practice

165 DELASHMUTT: agrees -regulatory body to intervene if problem exists

185 CHAIR FORD: what is the objection to this regulation?

192 DELASHMUTT: the issue should be resolved this session

202 REP LUKE: discusses state's involvement
