070 MELANIE ZERMER, COMMITTEE ADMINISTRATOR: reviews the bill -5 amendment, submitted by Oregon Acupuncture Association (EXHIBIT G): -removes from definition of acupuncture ability to use it for treating

neurological, organic or functional disorders -clarifies that nutritional substances are vitamins and minerals -defines oriental pharmacopoeia -clarifies persons are not prohibited from practicing therapies within

their scope of practice

115 REP SHIELDS: questions still exist -meaning of traditional and modern techniques in line 15 -therapeutic methods in line 16 -oriental pharmacopoeia

138 CHUCK BENNETT, CHIROPRACTIC ASSOCIATION OF OREGON: our concerns are addressed on page 2 of A-engrossed SB 706: -lines 19 & 20: "limit any other licensed or certified health care

practitioner from practicing" -this bill is not designed to preclude chiropractic physicians or other health care practitioners from engaging from any therapy within their

scope of practice

160 ZERMER: explains purpose of limiting the limit with the insertion of the words, "accupressure and accutherapy"

BENNETT: the language is acceptable -a chiropractor holding forth to his patient that he practices

accupressure or any other therapy is not going to be stopped -discusses

advertising of specialties

- 218 DELL ISHAM, OREGON ASSOCIATION OF NATUROPATHIC PHYSICIANS: summarizes concerns: line 15, page 1 line 17 and the following subsection 2 page 1a, line 29 page 2, lines 1 & 2 -would like to delete the above lines -this is definitely expansion of scope of practice -the bill is vague in some parts and needs to be more specific

- ISHAM: It appears that those sections are in conflict
