HB 2183 - Work Session

CHAIR FORD: This bill is back in committee for reconsideration in order to separate the issues -this committee will deal only with the X-ray fee program and the cost

of the inspections

018 MIKE SKEELS, HEALTH DIVISION: discusses costs of programs -two biennia ago the general radiation control aspects, separate from

the X-ray inspection fees, was funded largely by the state general fund -the fee was raised from \$30-40 to \$100 for the current biennium -there was a sunset on the \$100 fee, reverting to \$30-40 level if no

action is taken -the tanning bed inspection process began with \$25 fee

067 TOM JOHNSON, ENVIRONMENT & HEALTH SYSTEMS, HEALTH DIVISION: some general fund also went into subsidizing the inspection of dental and

other X-ray units -the \$30-40 fee did not cover all the costs of the program -the \$30-40 fee will not cover regular inspections -discusses tanning bed inspection fees -actual cost of X-ray program is \$693,721 for the biennium

120 REP EIGHMEY: wants information on frequency of inspections

CHAIR FORD: the problem is that there is an annual or biennial fee, and the machines are inspected every three years -inspections average \$200 each

240 REP EIGHMEY: discusses actual inspection

JOHNSON: describes what is included in the inspection

315 SKEELS: discusses establishing a different fee schedule relating to inspections
