SILKE: Replies that they can garnish wages without reducing the debt to judgement. -Does not have to be renewed every 90 days.

REP. MASON: Asks Silke what other entities have continuous garnishment

abilities.

SILKE: Department of Revenue and Support Services have this ability.

JOE McNAUGHT, DEPARTMENT OF JUSTICE: States what kinds of Organizations have garnishment powers.

SILKE: Tries to keep this type of wage control as discussed in HB 2044

a voluntary deduction to make room for other types of garnishments.

TAPE 2, SIDE A

McNAUGHT: Discusses different types of garnishments and how they are

applied and enforced.

REP. MASON: Asks McNaught why they need a special kind of garnishment.

McNAUGHT: Replies that it will relieve the State Scholarship Commission the task of renewing a garnishment every 90 days.

GENE POTTER, DIVISION OF AUDITS: Discusses bill and findings of the

Audit Commission. -Indicates that the bill would ease the Scholarship Commission in terms of efficiency.

JIM MARKEE, OREGON COLLECTORS ASSOCIATION: Testifies in opposition of HB 2044.
