well the boldface language on these two lines. -Deleting Section 2. This is essentially the bill as it currently

reads.

060 JANET ARENZ, ACLU: Testifies in favor of deleting Section 2 from HB 2349.

072 HOLLY ROBINSON, COMMITTEE COUNSEL: Addresses issues of mandatory arrest procedures and minors in the bill.

149 REP. EDMUNSON: Suggests the bill be sent out in original form.

180 CHAIR BRIAN: Hearing no objection, the motion CARRIES. 182 MOTION: REP. EDMUNSON: Moves HB 2349 AS AMENDED to the full committee with DO PASS recommendation.

190 CHAIR BRIAN: The motion CARRIES.
