002 CHAIR BRIAN: calls the meeting to order at 1:40 P.M.

HB 286 - PUBLIC HEARING

020 DAVE FISKUM, SISTERS OF PROVIDENCE HEALTH CARE SYSTEMS: Representing JOAN MAHLER submits written testimony in support of bill SB 286-A.

062 ULUM: Amendment from hospital association will be coming, and we would like to give our support.

065 REP. MASON: Requests copies of declaration on euthanasia, prolongation of life?

073 REP. HAYDEN: Why is there such a strong representation on this bill from the Sacred Heart Medical System, and particularly from Eugene?

076 ULUM: Most medical systems/ hospitals, are in Sister of Providence System.

080 REP. HAYDEN: Most Catholic hospitals belong to Sacred Heart System?

081 ULUM: No, to Sisters of Providence.

091 COURTNEY CAMPBELL, OREGON STATE UNIV. - TEACHER. Submits written testimony in support of medical ethics on SB 286. (EXHIBIT D). Ethically reputable. Does not support mercy killing. Inform choices, with

safeguards, presumption, who decides.

200 REP. MASON: Discussion of article from Holland. Submits article from New York Times to board members. What are the specific, concrete

guidelines going to be?

254 CAMPBELL: Can't transpose what happened in Holland to what will happen here. Holland has different medical treatment. Factors prevalent in

the U.S. that weren't present in Netherlands. Challenges applicability

to Oregon.

310 CAMPBELL: Resumes testimony.

415 REP. HAYDEN: In the community of ethicist would you have any colleagues that would debate you?

TAPE 65, SIDE A

010 CAMPBELL: Yes, the intention in withdrawing feeding tubes, is not to cause death but to end pointless medical treatment.

049 TINA KITCHIN, PHYSICIAN FOR DD SERVICES: Submits written testimony (EXHIBIT E), in basic support of SB 286.

110 REP. HAYDEN: Questions phrasing of words, "if reasonably available of neurological specialist".

112 KITCHIN: Some cause for concern is reasonable. But having the wording there we can demand for it to happen. It's a workable compromise.

122 REP. PARKS: Your amendments were adopted?

126 KITCHIN: For most part. If you don't have someone as close as a guardian or a spouse, you are then required to ask everyone even if not qualified. 135 REP. PARKS: Distinction being one person to override decision. A majority rules?

139 KITCHIN: 1) Look for guardian, 2) Look for consensus of a decision maker, if you don't get consensus - 3) Go to spouse.

154 REP. PARKS: Cites page 21, spouse is one group, adult children, and then parents. Anyone could bar decision.

165 KITCHIN: The first person contacted appropriately is designated guardian. If you don't end up with anyone, spouse by itself gets

opportunity to make decision.

177 REP. PARKS: How do you get there?

179 KITCHIN: Under supervision or request of following, A-guardian, B-adult, C-spouse. Objection clause only applies to B.

D-adult, E-majority of siblings.

206 CAROLE SOUVENIR, COMMITTEE COUNSEL: Agrees with testimony. You have to go through order A-G. If no person listed objects to designation.

If someone does object, you can't look to B, you have to go to C-spouse, etc. Proposed amendment puts spouse ahead of objection clause, and then consensus of all individuals.

232 CHAIR BRIAN: Amendment would help.

238 REP. PARKS: In the Senate, example: the principal spouse has left, in your amendment you give them priority. That's why they did that.

249 KITCHIN: If spouse is present than usually involved in persons life. If you can't agree on B (adult), then you end up with list that no one

can veto over. Cites example.

270 CHAIR BRIAN: Funeral arrangements unspecified. Who should really decide?

293 REP. BAKER: Whoever pays the bill. You would find out who is interested. Anyone could apply to court to appoint guardian, then court could override spouses interest, if necessary.

322 ROBERT W. SMITH, GOVERNORS COMMISSION FOR SENIOR CITIZENS: Testifies and submits written testimony in support of bill. (EXHIBIT F)
