CAROLE SOUVENIR, COMMITTEE COUNSEL: explains HB 2984

REP. EDMUNSON:

PUBLIC HEARING ON SB 288

(SB 288 Revises professional corpoaration law)

BILL TAYLOR, SENATE JUDICIARY: Testifies in support of SB 288.

REP. BRIAN: 1991 proposal attempted to limit liability to the partner who might be at fault, and the other shareholders would not have

been liable.

Taylor:

Charlie Williamson, Oregon Trial Lawyers Association (OTLA): Testifies in support of SB 288. Not happy with the bill, but is compromise.

REP. BRIAN: there is still adequate motivation ...

Williamson: yes.

Bob Wynhausen, Oregon Society of Certified Public Accountants (OSCPA): Testifies in support of SB 288. This would put us more in line with the rest of the country.

Sen. Bob Shoemaker, District : Testifies in support of SB 288. It is very important, they do have responsibility for each other. It imposes a \$300,000 on vicarious liability.

Andrew J. Morrow, Oregon State Bar: Testifies and submits written testimony in support for SB 288.
