005 CHAIR BRIAN: Calls the meeting to order at 2:26 p.m.

WORK SESSION ON SB 201

015 CAROLE SOUVENIR, COMMITTEE COUNSEL: SB 201 provides that adoption laws do not prevent adoption agreements allowing contact between birth family and adoptive family. Discusses -1 amendments, Section 1 lines 9-11

would be deleted. (EXHIBITS A & B)

031 REP. BRIAN: Confirms that the -2 amendments would require that the agreement be a sealed order, and amends the -1 amendments provide they

be open to the public?

036 CHAIR BRIAN: If it's not sealed then the public would see the name involved.

038 REP. BAKER: I'd rather it be a private document. If there is a violation, a person can go back and register with the court and ask the court for declaratory judgement and enforcement.

041 REP. EDMUNSON: Favors the -2 amendments.

045 REP. BAKER: It is a private agreement between the parties and

shouldn't be a part of the court record. 050 CAROLE SOUVENIR, COMMITTEE COUNSEL: Asks Rep. Baker, if he favors the -1 amendments.

056 REP. BAKER: The -1 amendment does not make a requirement for it to be a part of the court record?

057 CAROLE SOUVENIR, COMMITTEE COUNSEL: It would be approved by the court but it would not be part of the adoption records.

058 REP. EDMUNSON: The court file would be public?

059 CAROLE SOUVENIR, COMMITTEE COUNSEL: No, the adoption file would be sealed.

060 REP. EDMUNSON: So whatever the court has would be sealed, but this agreement would not be a part of it officially, even though the court

has to approve it? In the -2 amendments, the court would approve it and it would become part of the record that would become sealed.

064 CAROLE SOUVENIR, COMMITTEE COUNSEL: But then it wouldn't be enforced by a civil action, it would be enforced just like any other court order.

070 REP. BRIAN: Concerned that a third party could see unsealed information. Either way, is that protected?

075 CAROLE SOUVENIR, COMMITTEE COUNSEL: Anyone else can get a copy of the agreement, even if it is a private agreement. But if it is part of the

court file, a third party couldn't get it.

077 REP. BAKER: The danger of Section 1 in the -2 amendments is that, if it's not part of the confidential record, anyone could look at the

record.

083 REP. EDMUNSON: I doesn't protect the agreement. The -1 amendments don't make it part of the court file, and then it is up to the parties

to disclose information.

093 MOTION: REP. EDMUNSON: Moves to ADOPT SB 201-1 AMENDMENTS. With deletion of pg. 1, lines 9-11.
