BROWN: Doesn't matter if within statute of limitations. 136 REP. COURTNEY: Should get more information on this. 144 CHAIR TIERNAN: Asking Holly Robinson about a technical question about emergency clause. HOLLY ROBINSON, LEGISLATIVE COUNSEL: If there is in fact an 151 emergency clause, it may remain in effect within five days of it's signing. The difference may be six months, or within 90 days after session ends. REP. COURTNEY: Questions effectiveness 177 of bill as soon as Governor signs if there is an emergency clause. Otherwise, without emergency clause, then 90 days after session ends. HOLLY ROBINSON, LEGISLATIVE COUNSEL: 90 days after session ends. 189 Discusses 1989 session and timing of signing by Governor.
