HB 3427 - WORK SESSION

005 HOLLY ROBINSON, COMMITTEE COUNSEL: HB 3427 clarifies that administrative agencies have the authority to engage in alternative dispute resolution processes where conflict may arise. There are -2 amendments. (EXHIBIT A)

013 MOTION: REP. TARNO: Moves TO ADOPT HB 3427-2 AMENDMENTS dated May 26, 1993.

VOTE: Hearing no objections the amendments are ADOPTED. Rep. Courtney is excused.

014 MOTION: REP. TARNO: Moves HB 3427 AS AMENDED TO FULL COMMITTEE with a DO PASS recommendation.

HB 2033 - WORK SESSION

019 HOLLY ROBINSON, COMMITTEE COUNSEL: HB 2033 changes procedures and processes related to the reporting and remitting of unclaimed assets.

027 REP. BROWN: Disappointed that Section 24 was deleted but it is still a good bill.

029 MOTION: REP. BROWN: Moves to ADOPT HB 2033-3 AMENDMENTS dated May 27, 1993.

VOTE: 3-0 MOTION PASSES AYE: Brown, Tarno, Tiernan NO: None

034 MOTION: REP. TARNO: Moves HB 2033 AS AMENDED TO FULL COMMITTEE with a DO PASS recommendation.

VOTE: 3-0 MOTION PASSES AYE: Brown, Tarno, Tiernan NO: None

044 MOTION: REP. TARNO: Moves to SUSPEND the rules to allow Rep. Courtney to vote on HB 2033 as amended.

VOTE: Hearing no objections the rules are suspended. All members are present.

046 CHAIR TIERNAN: Having suspended the rules to allow Rep. Courtney to vote on HB 2033 as amended, Rep. Courtney votes "aye."

HB 2887 - WORK SESSION

047 HOLLY ROBINSON, COMMITTEE COUNSEL: HB 2887 modifies terms in abuse reporting statutes by adding more specific terms of "assault" and "rape of a child," which includes rape, sodomy, unlawful sexual penetration and incest. There are amendments. (EXHIBIT C)

059 MOTION: REP. COURTNEY: Moves to ADOPT HB 2887- AMENDMENTS.

VOTE: Hearing no objections the amendments are ADOPTED. All members are present.

062 MOTION: REP. COURTNEY: Moves HB 2887 AS AMENDED TO FULL COMMITTEE with a DO PASS recommendation.

REP. BROWN: Wants to know what the amendments do in terms of changing the reporting requirements.

073 ARNIE GREEN: Hasn't seen amendments.

078 CHAIR TIERNAN: Amendment is to take out term "sexual abuse" so as not to confuse it with other terminology and put it into a separate section.

HOLLY ROBINSON, COMMITTEE COUNSEL: It does nothing to the reporting statutes. These are just definitions. A Sex Abuse III offense is termed "rape" under child abuse reporting statutes. Describes two reporting terms.
