006 CHAIR PARKS: Calls the meeting to order at 1:38 p.m.

PUBLIC HEARING ON SB 321 & 322

\*SB 321 Establishes crime of public investment fraud. (EXHIBITS A,B) \*SB 322 prohibits knowingly presenting false claim to public body for payment. (EXHIBIT C)

Witnesses: Sen. Grattan Kerans, District 20 Elise Fulsang, Marion County District Attorney Terry Leggart, Department of Justice Fred Avera, Oregon District Attorney Association

016 SEN. GRATTAN KERANS, DISTRICT 20: Testifies in support of SB 322 and SB 321. 033 REP. TARNO: Asks about the Oregon State Police funding package that is included in the bill.

 $035\,$  SEN. KERANS: Concerning SB  $\,$  321, the cost should be  $\,$  part of the ongoing business.

053 CHAIR PARKS: How are SB 321 and SB 322 different?

054 SEN. KERANS: Explains the differences of SB 321 and SB 322.

073 REP. BAKER: Asks about the law against false claims.

074 SEN. KERANS: Explains that the cases weren't tried under fraud claims. SB 321 also provides ways for civil action and recovery.

086 REP. TIERNAN: Asks about someone who willfully over-values a piece of property, etc., and what the difference is between "shopping around" for the best price.

093 SEN. KERANS: Explains that "shopping around" is outside the customary practices. There has to be evidence of inflating the value of

something.

110 ELISE FULSANG, MARION COUNTY DISTRICT ATTORNEY: Testifies in support of SB 322.

165 REP. BAKER: Asks if the bill is only limited to PERS investment.

168 FULSANG: No. This bill is not to be focused on PERS, but to expand on the federal legislation.

175 REP. TIERNAN: How often would this be invoked?

179 FULSANG: Explains the speculations.

194 REP. TIERNAN: What is the need for the bill?

195 FULSANG: Explains that under the existing statutes, most people can't be prosecuted.

203 REP. BROWN: Asks about a newspaper article concerning Medicaid.

212 FULSANG: Doesn't know the case, but explains what she would have done in a similar situation.

222 CAROLE SOUVENIR, COMMITTEE COUNSEL: Asks if Section 9 refers to a civil suit, or any suit.

227 FULSANG: That refers to a civil suit.

235 CAROLE SOUVENIR, COMMITTEE COUNSEL: A person wouldn't be charged under the assurance for voluntary compliance if they were going to charge them criminally?

237 FULSANG: Correct.

239 CHAIR PARKS: Why should there be priority in civil suits over other suits?

242 FULSANG: Explains that it was modeled under a racketeering statute.

249 CHAIR PARKS: Objects that the statute is used so often that it is now not priority. Asks if the bill says that a person has to be given the

opportunity of civil compromise.

264 FULSANG: Explains that, as written, that does occur in the bill.

267 CHAIR PARKS: That would change with the wording "shall"?

268 FULSANG: Correct.

271 REP. BAKER: If this is mandated, it takes away the flexibility of the law.

281 REP. TIERNAN: Could this apply to things like a false expense account?

283 FULSANG: Yes, if the account was filed as a claim.

291 REP. TIERNAN: Gives example, and asks if this would apply.

301 FULSANG: If the expenses were over \$100, yes.

308 REP. TIERNAN: Could this apply to election laws?

310 FULSANG: Possibly, cites where "false claim" is defined.

322 REP. BAKER: Are election laws exclusive?

325 REP. TIERNAN: Explains the reason for asking about election laws.

340 FULSANG: Cites definition of "reimbursement", and explains that false claims have to be using money coming from the state.

351 CHAIR PARKS: This would be a class C felony?

354 FULSANG: Yes, explains the key elements.

378 TERRY LEGGART, DEPARTMENT OF JUSTICE: Testifies in support of SB 322 .

402 CHAIR PARKS: Refers to SB 321, and asks about someone giving a false report and what the consequences would be.

415 LEGGART: Not familiar with SB 321. Discusses the civil standard dealing with cases on appraisal.

443 CHAIR PARKS: Discusses the wide standard of appraisal.

449 LEGGART: Discusses the possibility of being sued civilly for false appraisal.

380 REP. BAKER: Discusses the prosecutor's responsibility. Wants to rephrase the federal language as stated in the bill.

394 CAROLE SOUVENIR, COMMITTEE COUNSEL: States the rephrased federal language concerning fraud.

405 REP. BAKER: Suggests deleting words after "report" on pg. 1, line 6.

411 MOTION: REP. BAKER: Moves to AMEND SB 321 by deleting the language following "report", on pg. 1, line 6. The coma would then

become a period.

VOTE: Hearing no objections the amendments are ADOPTED. Rep. Brian, Edmunson, and Mason are excused.
