169 ROBINSON, COMMITTEE COUNSEL: Gives Staff Measure Summary and review of HB 2483.

MOTION: REP. COURTNEY: Moves to ADOPT the -2 amendments to HB 248 3.

VOTE: CHAIR PARKS: Hearing no objections the motion CARRIES.

MOTION: REP. COURTNEY: Moves HB 2483 be sent to the Floor with DO

PASS recommendation.

REP. MASON: Asks Rep. Courtney how this piece of legislation will be

funded.

220 REP. COURTNEY: Replies by stating that there are other bills which may allow for an adjustment of the budget.

260 REP. MASON: Gives statement on Rep. Courtney's ideas of funding.

329 REP. BRIAN: Asks if indicated prior convictions are sexual offenses or otherwise (in relation to the individual's felony convictions as related in this bill).

350 REP. TIERNAN: Gives answer that prior convictions were: A. Indicated by more than one conviction and B. Not necessarily related to sexual

offenses.

375 REP. BRIAN: Would like further clarification on criminal's status as it relates to the bill.

388 REP. TIERNAN: Judge and district attorney must find conduct of the person such that it warrants a label of "extremely offensive."

390 CHAIR PARKS: Asks counsel for details on a judge's discretion and activity of prosecutor and district attorney in this matter.

410 ROBINSON, COMMITTEE COUNSEL: Replies that a judge has discretion in how criminal history is calculated and the individual is sentenced.

TAPE 11, SIDE A

013 CHAIR PARKS: If a judge finds that a person has been convicted of a prior crime, does he or she have to apply this statute and consequently double the sentence? 014 ROBINSON, COMMITTEE COUNSEL: Yes, if it has been presented to the court in a fact-finding manner.

017 CHAIR PARKS: What if the person is charged with both kidnapping and rape? How is this bill applied?

023 ROBINSON, COMMITTEE COUNSEL: Replies that it may not necessarily be applied in this situation.

026 CHAIR PARKS: Calls witnesses up for CLARIFICATION OF ISSUES ONLY, NOT OFFICIAL TESTIMONY.

ROSS SHEPHERD, OREGON CRIMINAL DEFENSE LAWYERS ASSOCIATION: Explains terms of statute in terms of prior criminal convictions.

FRED AVERA, DEPARTMENT OF CORRECTIONS: Further clarifies issue by

stating that two convictions arising from same incident will not qualify as prior convictions.

SUSAN TRIPP, OREGON DISTRICT ATTORNEYS ASSOCIATION: Agrees with other

witnesses in regards to details on prior convictions.

068 REP. MASON: Asks how one proves "dangerousness."

078 AVERA: Indicates that dangerousness can be identified with prior criminal records.

100 REP. TIERNAN: Makes statement regarding philosophical costs of protecting society as opposed to actual monetary expenditures.

113 CHAIR PARKS: Comments on goals of committee and the choices they must make through the session.

130 REP. BRIAN: Expresses confidence in judicial system in regards to abuse of this statute.

140 REP. COURTNEY: Comments on changes made in legislation and degree of seriousness inherent in the bill.

183 REP. MASON: States that bill's intent is to not help the sex offenders nor will it be easy to pass this bill due to monetary considerations.

VOTE: In a roll call vote, all members vote AYE with the exception of REP. MASON who votes NO.

CHAIR PARKS: The motion CARRIES.

REP. COURTNEY will lead the discussion on the Floor.
