005 CHAIR WATT: Calls the meeting to order at 4:20 p.m.

WORK SESSION ON SB 167 C

010 CHAIR WATT: Explains the work that needs to be done on the
Governor's reorganization package.

011 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains the
amendments in

the staff packet. (EXHIBIT A)

028 MOTION: REP. BAUM: Moves to ADOPT the SB 167 C-18
amendments.

030 REP. JOHNSON: Asks if the -18 amendments include more than
technical

changes.

032 CHAIR WATT: Discusses the Boxing and Wrestling Commission.

038 VICE-CHAIR ROBERTS: Asks about the changes to the boards.

VOTE: CHAIR WATT: Hearing no objection, the amendments are ADOPTED. Rep. Hayden, Rep. McTeague, and Rep. Payne are excused.

046 CHAIR WATT: Discusses C-19 amendments.

MOTION: CHAIR WATT: Moves for unanimous consent to reconsider the C-19 amendments that are similar to the B-12 amendments that failed in an earlier meeting.

VOTE: CHAIR WATT: Hearing no objection, the amendments will be reconsidered.

057 REP. GORDLY: Asks about the status of the C-19 amendments.

067 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains the C-19 amendments. Explains the staff annotation. (EXHIBIT B) Explains that the amendments would abolish the State Structural Code Advisory Board and the Energy Conservation Board, and merge the two boards in the Department of Consumer Business Services.

081 CHAIR WATT: Asks if the Committee will have to wait for the -20 amendments to make the changes effective.

083 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains that the -20 amendments will only be needed if the Committee fails to adopt the C-18 amendments.

088 CHAIR WATT: Explains that the language could be taken care of in conference committee.

092 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains that new amendments will have to be drafted if the Committee adopts more than the -18 amendments.

097 REP. BAUM: Asks how long it would take Legislative Counsel to prepare the -20 amendments.

099 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains that the -20 amendments would be the compilation of the adopted amendments.

104 VICE-CHAIR ROBERTS: Explains that two separate boards can operate better than one put together.

110 REP. MCTEAGUE: Asks if the Committee had voted this bill out a few weeks ago.

112 CHAIR WATT: Explains that the bill was referred back to the Committee.

115 MOTION: REP. BAUM: Moves to ADOPT the SB 167 C-19 amendments.

121 REP. MCTEAGUE: Asks about the duplication of the amendments.

122 CHAIR WATT: Explains that the amendments were previously the -12 amendments that were defeated. 126 REP. MCTEAGUE: Explains that the boards serve two different and unrelated functions. The boards should not be combined.

VOTE: 5-3 Motion passes AYES: Baum, Hayden, Johnson, Milne, Watt NO: Gordly, McTeague, Roberts EXC.: Payne

135 VICE-CHAIR ROBERTS: Asks for clarification on Mr. Kosesan's amendments.

139 RICHARD KOSESAN, OREGON ATHLETIC TRAINERS SOCIETY: Explains the athletic trainer amendments. (EXHIBIT C)

154 MOTION: REP. ROBERTS: Moves to ADOPT the KOSESAN amendments.

157 CHAIR WATT: Explains that the amendments might be taken out of the bill in conference committee.

171 REP. HAYDEN: Explains that he will not support the amendment.

VOTE: 6-2 Motion passes AYES: Baum, Johnson, Milne, McTeague, Roberts, Watt NO: Gordly, Hayden EXC.: Payne

183 VICE-CHAIR ROBERTS: Asks if there are any other amendments for this bill.

184 CHAIR WATT: Explains that the bill can't be moved out of Committee until the bill has a fiscal impact statement.

187 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains that the Committee will want to see the fiscal impact before passing the bill out.

194 REP. BAUM: Asks if conflict amendments will need to be prepared before the bill is moved.

199 CHAIR WATT: Explains that it is his intention to move the legislation.

208 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains the previous work

session and testimony. (EXHIBIT D) Explains the need for compliance.

238 REP. JOHNSON: Asks if the federal rules have been written to deal with the programs implementation.

240 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains that the rules have not been written.

251 MOTION: REP. ROBERTS: Moves SB 453 B to the Floor with a DO PASS recommendation.

VOTE: 7-0 Motion passes AYE: Baum, Gordly, Hayden, Johnson, Milne, Roberts, Watt NO: None EXC.: McTeague, Payne

REP. GORDLY will lead discussion on the Floor.

PUBLIC HEARING ON SB 1135 Witnesses: Frank Brawner, Oregon Banker's Association

271 FRANK BRAUNER, OREGON BANKER'S ASSOCIATION: Submits and reviews written testimony in favor of SB 1135. (EXHIBIT E) Explains that SB 1135 replaces SB 575.

335 VICE-CHAIR ROBERTS: Discusses farmers losing crops.

344 BRAUNER: Discusses the ninety day automatic lien.

WORK SESSION ON SB 1135

356 MOTION: REP. ROBERTS: Moves SB 1135 to the Floor with a DO PASS

recommendation.

359 REP. GORDLY: Asks if there is anyone that is opposed to this bill.

361 CHAIR WATT: There are parties opposed.

362 REP. GORDLY: Are they here?

363 CHAIR WATT: No, they are not.

364 BRAUNER: Explains that no one has testified against the bill. The bill unanimously passed the Senate.

377 CHAIR WATT: Explains that there is a member of the body that indicates that there might be some problems with the bill. The member has not yet read the bill, but is basing the opinion on the old bill.

396 REP. GORDLY: Explains that she would like the opposition noted for the record.

399 REP. BAUM: Explains that he has not been contacted by any opponents of the bill.

402 CHAIR WATT: Explains that if there were concerns with the Agricultural Community, they would have notified the body.

VOTE: 6-0 Motion passes AYE: Baum, Gordly, Johnson, Milne, Roberts, Watt NO: None EXC.: Hayden, McTeague, Payne

REP. BAUM will lead discussion on the Floor.
