004 CHAIR WATT: Calls the meeting to order at 1:46 p.m.

WORK SESSION ON SB 167 C

007 CHAIR WATT: Discusses the amendments and the fiscal.

009 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains the
appropriate motion for passing the bill out. (EXHIBIT A) Explains that
there is no

longer a subsequent referral to the Appropriations Committee.

012 MOTION: REP. ROBERTS: Moves to ADOPT the SB 167 C-20
amendments.

014 REP. MCTEAGUE: Explains that combining these two boards is ill
advised. This is bad public policy.

019 CHAIR WATT: Explains that the -20 amendments are more than
the combination of the two boards. 020 ADRIENNE SEXTON, COMMITTEE
ADMINISTRATOR: Explains that the amendments are comprehensive. It
contains the athletic director's amendment, board combination amendment,
and conflict amendments.

028 VICE-CHAIR ROBERTS: Explains his vote.

030 REP. MCTEAGUE: Asks for clarification on the section that deals with the Boxing and Wrestling Commission.

034 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains the portion of the conflict amendments that deal with the Boxing and Wrestling Commission.

051 REP. GORDLY: Asks where HB 2125 is.

053 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains that it has passed both chambers.

VOTE: 5-2 Motion passes AYES: Baum, Hayden, Milne, Roberts, Watt NO: Gordly, McTeague EXC.: Johnson, Payne

065 MOTION: REP. ROBERTS: Moves SB 167 C, AS AMENDED, to the Floor with a DO PASS recommendation.

VOTE: 6-1 Motion passes AYE: Baum, Gordly, Hayden, Milne, Roberts, Watt NO: McTeague EXC.: Johnson, Payne

REP. WATT will lead discussion on the Floor.

WORK SESSION ON SB 349

078 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains the past work sessions on the bill. Explains the -7 amendments. (EXHIBIT B)

Explains the sunset provision and the fiscal impact statement.

118 REP. MCTEAGUE: Asks about the origin of the bill.

120 ADRIENNE SEXTON, COMMITTEE ADMINISTRATOR: Explains that the concept was originally contained in HB 2004. The group, Children First, is the

proponent of the bill.

134 REP. GORDLY: Explains that the bill was introduced by Sen. Roberts.

142 MOTION: REP. ROBERTS: Moves to ADOPT the SB 349 B-7 amendments.

VOTE: 7-0 Motion passes AYES: Baum, Gordly, Milne, McTeague, Payne, Roberts, Watt NO: None EXC.: Hayden, Johnson

149 MOTION: REP. ROBERTS: Moves that SB 349 B be returned to the Speaker's desk with a letter requesting that the bill be referred to the Committee on Appropriations with a DO PASS recommendation.

153 REP. MCTEAGUE: Clarifies that the funds are coming from of a private source. Asks about the reason for the referral to Appropriations.

160 CHAIR WATT: Explains the expenditure agreement that automatically sends bills to Appropriations.

162 REP. MCTEAGUE: Asks if the Chair of Appropriations will move the bill.

163 CHAIR WATT: Explains that he is not aware of the Chair's intentions.

165 REP. MCTEAGUE: Asks if the bill could be sent to the Floor.

166 CHAIR WATT: The bill will go to Appropriations.

VOTE: 6-1 Motion passes AYE: Baum, Gordly, Milne, Payne, Roberts,
Watt NO: McTeague EXC.: Hayden, Johnson
